You are to conduct yourself in a sportsmanlike manner and obey all rules and regulations set down by **MBC** and its Board of Directors. Verbal or physical abuse of any player or other person at the ball field or at a place where you attend as a unit from **MBC** will not be tolerated. This will result in your immediate dismissal as coach.
