December 10, 2017

Call to Order:

Keith Davison called the teleconference meeting to order at 3:05pm.

Roll Call:

- Presented November minutes
- Michelle Kaster made a motion to accept the minutes
- Chris Lynch seconded the motion
- No discussions
- Motion passed unanimously

Treasurer: Jeff Strueder

- Had emailed his report to the office but it was not distributed, will be uploaded
- Will show as of the end of November, a negative \$13,000 that represents a substantial transfer from PayPal
- Still working through Sharon Dowden's name as owner of our PayPal account but it doesn't affect our ability to do business
- Due to the inability to actually review the report, Tina Fouts motioned to move the approval to the February board meeting
- Pat Culp seconded the motion
- Motion passed

Old Business

Review of process to replace officers

- Keith Davison reported that 3 officers' positions were replaced using undocumented protocol, used previously for these occasions
- Currently a committee is in the process of reviewing and updating our bylaws. The situation of replacing executive officers who resign mid-year will be addressed in the updated bylaws
- Discussions about the choice of replacing JD Minch's position with Jim Tonte
- We have a functional team of officers in place and will be moving forward
- Tina Fouts reported the members of the committee reviewing/updating the bylaws
 - o Tina Fouts, Steve Pugliese, Pat Culp, Sharon Dowden, Rex Peckinpaugh, JD Minch
- The intention is to have the proposed updated bylaws ready to distribute by the end of March for review by the board and then to present them to the full body at the annual meeting in September
- Keith Davison spoke of being an effective board and to lead positively
- Asked that we move forward as a board, asking that we all maintain the positivity and try to respond with our frustrations or disagreements in a positive manner
- Asking all board members to help with recruitment when we have a board member resign, as Tom Dolly did 2 days ago
- With regards to Tom Dolly's resignation, we need to be reactive as far as replacing him, but if we can be proactive, we can have names at the ready if someone else resigns
- Jason DeLois would like to become more involved with the board

Fund Raising

- Keith Davison asked for all to keep their ears open and bring any possibilities for fund raising to him so that he can reach out to them
- Some companies will match volunteer hours with donations

- Jennifer Pierson stated that Finish Line has a program for donations to community organizations she isn't sure if the ISWA would qualify
- Will forward information to Keith Davison so that he can look into it
- Jake O'Neill had reached out to a steel company but wasn't successful
- Will be reaching out to Cummins soon as the wife of a local wrestling coach works there
- Jake O'Neill would like some guidance/help on the fundraising tasks
- Keith Davison stated that we will address that shortly in this meeting when we discuss replacing open positions on the board
- Pat Culp mentioned that someone might want to check with Parkview they give great donations. She
 doesn't know anyone there but she knows that they are great at supporting sports state-wide
 - o Thomas Pompei's wife works for Parkview. He will talk with her to see if she knows who to contact

Safe Sport Roll Call

- Individuals who have not yet complete Safe Sport need to do so ASAP
- Tina Tonte has added a link to the Safe Sport certification course on the website
- Keith Davison has a message in to Les Gutches with USA Wrestling to see if additional information on the website

Cadet Duals

- Being held in Spokane, WA
- Thomas Pompei and Cory Graham (team leader) are working on this
- Jake O'Neill reported that they have been discussing taking 1 large team of around 27 members and the athletes can wrestle both styles
- Bus is probably not going to work for transportation
- Sarah Frisz will reach out to airlines to checks costs and timing
- Keith Davison asked for a committee to be formed to work out details
- Danny Struck stated that by the end of January he will have one coach assigned to each duals trip
- Keith Davison stated that United Airlines is the official airlines of USA Wrestling Sarah Frisz will look into it

Schoolboy Showcase at NCAA

- Jim Tonte stated that he was contacted by Alex Joseph and Tiffany and that he has a call into Christina Hargrove with USA Wrestling who has not gotten back with him
- Still waiting to hear back from Pete Isais as well
- Has been told that the NCAA doesn't want to allocate tickets for the kids any longer but he hasn't had that verified yet
- Waiting to hear back regarding the situation

State Tournament Vendor choice

- Keith Davison reviewed the decision to choose 3x Gear as our state tournament vendor for this year (they were our vendor last year)
- He apologized for not presenting the decision to the full board for approval
- No questions were raised

Elementary State Duals

- Chris Lynch asked Pat Culp, Tina Tonte and JD Minch what the date is for getting names to the vendor for the back of the shirts
- Pat Culp needs the names of the teams participating as well as a coach's name and email address
- Tina Tonte will make sure that she has that information
- Discussion about setting rules for next year's tournament regarding year of birth

New Business

Open communication

- Keith Davison discussed the fact that anything we are doing should be discussed with the entire board such as strategy, leads for fundraising, etc.
- Going to try and do this moving forward so that we are doing things in a more democratic fashion

Safe Sport Issue

Had a complaint against a coach that was brought to us by the mother of an athlete

- Has been forwarded to Les Gutches with USA Wrestling for review
- Les Gutches decided that USA Wrestling should be handling the investigation
- Letter was sent to the club of the coach involved informing them that they need to cease operation until the investigation is concluded
- They can hold no practices or sanction any tournaments temporarily suspended
- Michelle Kaster has asked that these types of incidents be communicated more openly as she was caught in the cross-fire of this investigation with questions and she knew nothing about it
- Section Director needs to be aware of situations such as this
- Keith Davison asked that Disciplinary Committee notify the Section Directors regarding investigations, suspensions, etc.

Board Structure

- Keith Davison reported that our bylaws allow for 30 board members
- We currently have 21 directors with the following positions open
 - Equipment Director
 - o Women's Director
 - o RTC Director
- Fundraising Development Director candidate Nancy Campbell
 - Principal in the Floyd Central school district
 - o Bringing to the board for their thoughts
 - Jennifer Pierson feels she would be a good asset to the board, has a lot of contacts and a good way of speaking and presenting things. Thinks she would do a great job
 - Jim Tonte talked about what a great asset she was at the Walker Career Center and Warren Township Schools and that she has more contacts now that she is working in the southern part of the state. He thinks she would do a great job
- Jake O'Neill mentioned someone that he thought might be interested
 - Scott Brannon with Simon Youth Foundation wrestled at Ben Davis and Wabash College
 - Feels he would be a good candidate this is what he does for a living
- Keith Davison said that we need to be selective in our choices and not just fill a position to be filling it
- Will reach out to Scott Bannon to determine his interest. Jim Tonte feels he would do a good job as well
- Jason Miller asked if here would be a conflict to have them both do it
- Keith Davison feels one person should be in the role for accountability
- Keith Davison is thinking of having a director and a committee to work on fundraising for the organization
- Asked the board if he could have permission for the Executive Board to do a little more due diligence and then extend an offer to the appropriate candidate
- Jason Miller made a motion for Keith's request to be approved
- Jennifer Pierson seconded the motion
- Motion passed with one dissention
- Keith will move forward with this and will have a director by next week, with a committee

IT Director (open position)

- Chris Pruitt has been doing work for us in the office and has provided a lot of help and charged us a little bit
- Tina Tonte has had a positive experience
- JD Minch has only met with him once
- Keith Davison spoke with both Pat Culp and Patt VanHorn about IT needs for tournaments
- Wants to make sure we are doing our due diligence with our choice for IT Director
- Pat Culp indicated she has talked with him a few times about what the needs would be at tournaments
 - o Wi-Fi at tournaments, new computers (warranty was found)
 - Has to make sure we can get trackwrestling downloaded for streaming
 - Stated he seems nice enough but she cannot honestly give her recommendation yet as she has not really worked with him yet
- Keith Davison asked if she would like to have him involved with Elementary Duals
 - She indicated that she would like to have him help
 - Bigger issue is that she needs to have him get the new computers up and running for High School State
 - Will know more after next week
- Keith Davison stated that we are not yet ready to move forward and we need to continue to do our due diligence

Regional Training Centers (RTC) - Open Position

- Danny Struck has been in discussions with the Coaches' Council and they have created a committee
 - Danny Struck, Jim Tonte and Leroy Vega
 - Will be working to evaluate attendance at RTCs and what direction we need to be moving
 - Working to create a job description
 - Goal is to have practice format in place and expectations of a RTC and how they should conduct themselves
 - Leroy Vega has confirmed that if he was called upon to serve that he might consider it
- Mission statement/job description will be completed in January
- Plans to re-evaluate locations for 2019 since they are already printed for 2018

Women's Director – Open Position

- Tom Dolly resigned as of this past Friday
- Jason DeLois and a few others have expressed interest in becoming involved
- Danny Struck would like the coaches' council to make the recommendations for Women's Director and RTC Director
- Tina Fouts stated that we need to make sure that the individuals who take on these roles understand that they need to help in running the state tournaments

National Teams Gear

- Keith Davison has aggregated the national teams headcount to give vendors an opportunity to bid
- Asked if there are any candidates for the Equipment Director's role no one spoke up with recommendations
- Continuing to look for the right person to fill the role
- Asked who was on last year's committee so that we can get things rolling in the next couple of weeks
- Chris Lynch explained the tasks/duties that need to occur are as follows
 - Reviewing the vendor, description of the equipment, doing the bids, seeing what fits into the budget that was set, quality of gear, design, ordering, making sure it gets to where it needs to be
 - There is typically a committee in place that helps the director through the process
- Discussed tournaments involved that will need national gear
- Jason DeLois asked for a copy of the job description Tina Tonte will send to him

- Over 130 coaches attended the IHSWCA clinic where we always plug ISWA
- Asked all to make sure that we are having all coaches of all trips to go through the application process – ensuring proper forms filled out which allows us to keep track of all interested parties for future trips

Cadet Director –Jake O'Neill

- Has communicated with Thomas Pompei about selecting staff for Cadet duals
- Was informed that Corey Graham was selected for Team Leader for the trip
- Communicated with Corey Graham about wrestlers and coaching staff for the trip
- Was suggested that we aim for one team of 27 to go on the trip with a team leader and two coaches
- Solicited Steel Dynamics for a sponsorship and/or donation for the Cadet Duals trip was declined
- Asked about the cost of sending out the publication and wondered if we could offer the printed book but they pay \$5 (or some nominal fee) for it
- Jeff Strueder reported that we paid \$11,378 last year but unsure it that included postage
- Determined this is a valid discussion but it will have to be for next year
- Suggestion was made to form a committee to look into the possibility of a change in delivery for next year – additional strategy – Keith Davison wondered about instead of waiting until June, wondered if 6 months is ample time to make the decision
- Maybe look at getting someone to do a digital book for Fargo and we could ask them to do a digital copy of our publication as well
- Tina Tonte said that Jason Miller talked about a website getting framework built for Fargo;
 Jake stated that Danny Struck has a network of emails that could be used for college recruitment guide
- Danny Struck recommended a google doc and email
- Keith Davison reported that there are some pretty cool pictures of Spokane that we could use through social media to try and sell the trip. Jake will work with Corey Graham and Danny Struck to pull some stuff together
