Parental (Guardian) Consent and Waiver of Liability

In acceptance of my (our) son/daughter or ward (name:) _____ as a member of the 2018 Hawaii National Wrestling team for the period of July 13th, 2018 through July 20th, 2018, it is agreed that the Hawaii National Wrestling Team and its coaches/staff, and/or Hawaii Federation of USA Wrestling will not be held liable for injury to the above named wrestler arising out of or in connection with the operation of said team, or his/her participation in team activities such as but not limited to workouts, conditioning drills, competition, and travel to or from such activities/event. IT is further agreed that all risks attendant to participating in team activities including but not limited to bodily injury are assumed by the wrestler and his/her parent(s) or legal guardian(s), and that this assumption is acknowledged, approved, and agreed to by wrestler and his/her parents(s) or legal guardian(s) as indicated signature(s) below.

The wrestler agrees to abide by the expectations/rules set forth by the coaches and staff of the Hawaii National Wrestling Team in regard to his/her actions at the training and on the trip to and from Fargo, North Dakota at the Cadet and Junior Fargo Championships. Wrestlers that do not adhere to expectations will have disciplinary action deemed necessary by the coaches and staff of the Hawaii National Wrestling Team, and in the best interests of the team.

Wrestler further acknowledges that if his/her actions are deemed by the coaches and staff of the Hawaii National Wrestling Team to be severe enough, he/she may be sent home at any point (camp, training, or tournament) without warning, and will forfeit all moneys paid for his/her participation on the 2018 Hawaii National Wrestling Team (actions that may send a wrestler home include but are not limited to, use of illegal drugs or alcoholic beverages, theft or money or personal property, vandalism, and displays of temper or poor sportsmanship which reflect adversely on the Hawaii National Wrestling Team). Wrestler will also be asked to return all equipment and apparel including singlets he/she has been given in connection with participation on the team.

I (we), the parent(s) or the legal guardian(s) of above named wrestler hereby acknowledge that I (we) have read the above statements and conditions, and agree. I (we) also certify that I (we) have discussed these conditions with my (our) son/daughter or ward, and he/she has also agreed. Qualifying for Cadet/Junior Nationals, Fargo, ND

Notes:

1. Below are the qualifying events for wrestlers to participate in the Cadet/Junior National Championships in Fargo, ND as a member of Team Hawaii. Please Note: Qualifications are DIVISION (Cadet or Junior) and STYLE (Freestyle or Greco-Roman) specific.
2. A wrestler who qualifies through the Fargo Qualifier or the Freestyle and Greco-Roman HFUSAW State Tournament MUST wrestle at the weight they qualified at, they CANNOT change weight classes. However, after all qualifying tournaments are completed, if a slot is available in another weight class, a qualified wrestler will be eligible to move into that slot.
3. If a wrestler qualifies in more than one weight class they MUST declare what weight class they will be representing.
4. A wrestler who qualifies (with a top 8 finish) through any of the USAW regional championships or UWW national championships can wrestle any weight class they choose at the Cadet/Junior National Championships.
5. Male wrestlers that finish 1st in a qualifying tournament will be eligible for one of the 4 spots available in their weight class. If that wrestler does not wish to participate or if that wrestler is already qualified the 2nd place wrestler in that tournament will be offered the spot.
6. If there are unfilled weight classes, after all qualifying tournaments are complete, qualified wrestlers may change their weight class to fill one of those positions and the 2nd place finisher from their qualifying tournament will be offered the spot they left vacant.
7. If more than one qualified wrestler is trying to move into a vacant spot, a wrestle off will be offered and the winner of that contest will be awarded the vacant spot.
8. If wrestlers do not qualify through the events listed below, they can try to petition onto the team. Team spots will be opened up to wrestlers who have not met qualification procedures after all qualifying events are completed and the deposit date has passed. Priority will be given to returning USAW All-Americans, returning National Team members, and athletes who actively participate in HFUSAW events. An official wait list will be maintained by the Cadet/Junior Committee Chairman.
9. Wrestlers must fill out application and contact their division coordinator prior to weigh ins.

Hawaii National Team Qualifying Tournaments (Subject to Change):

1. Oahu April 14, 2018 Nanakuli High School
2. Maui May 5, 2018 Lahaina Civic Center
3. Oahu May 12, 2018 Waianae High School
4. Oahu May 19, 2018 Kaneohe Marine Base

*There is a 5lb weight allowance at all qualifier tournaments

After May 26, 2018 all unfilled spots will be first come first serve with \$200 deposit for uniform package. Uniforms/Team Hawaii Gear must be ordered by June 13th, 2018 or you will not be registered for the tournament. Last second wrestlers, you must participate in a HFUSAW tournament to be eligible to wrestle in Fargo. HFUSAW Freestyle and Greco Championships June 8-9, 2018 will be our last tournament of the season.
