# Parks and Recreation Report:

Chris Morrow Council and Park Board have decided to move ahead with the Gleason upgrades, and will begin a feasibility study. Will seek additional input from OMGAA. City may apply for additial grant monies to aid in development of this project. OMGAA will commit funding as well, most likely through installment payments. OMGAA will ask for artificial turf fields to increase flexibity of use and earlier access in spring.

T-ball and softball fields will be adjusted and may result in more field availability for OMGAA progams.

Field rental fees for tournaments will not increase over past years, but are scheduled to rise in 2020.

# **Old Business:**

Gleason Fields Development: Scott explained the timeline the city is considering and how OMGAA will have input into the planning. Scott will reach out to league directors to discuss needs. It is high priority for OMGAA to have turf fields and concessions capabilities. We could expect progress by May or June on city development plans.

Open Board Positions: Two board positions remain open, both in the Junior House programs.

Caleb Johnson introduced himself and provide background information regarding his history with the program. Caleb is interested in the 10-12 Jr. House League.

Motion to appoint Caleb Johnson to fill the Jr. House 10-12 League Directors Position through the 2020 term was made by Mark Seconded by Donna Motion was approved by unanimous voice vote.

#### **New Business:**

18U Traveling Fastpitch: Mark explained the situation behind the creation of the new 18U team and how the program will function within the Traveling Fastpitch Program. Discussion revolved on openning the program to all eligible players. Will set registration similar to Sr. Rec League where teams are registered fully formed rather than individual players. Action was approved in Consent vote, no further board action required.

Peachjar Flyer: Jon would like to send Peachjar flyer announcement, but cost is \$25 per school. Discussion revolved around how many schools and which programs should be involved.

Motion to approve up to \$500.00 for Peachjar Flyers was made by Tom Seconded by Rachel Motion was approved by unanimous voice vote.
