- Roster Turn In: Roster turn will be due by August 15th, 2025. Coaches Packets are online at www.okmgsa.com. Payments will need to be made at the time of registration. NO EXCEPTIONS! League Fees: \$315 for Team Entry Fee. Weeball is \$200 as they will play less games. (All forms in this packet will need to be filled out and scanned to a pdf, please no zip files.)

- If a team adds a player after the August 15th deadline, you must email the League Director. League Rosters will be FROZEN after your second night of league games. No players can be added after the second night of league games, period.
- Pre – Season Tournament: The pre-season tournament will be August 23rd – August 24th. It is FREE entry fee and only for all league teams. There is a gate fee for the pre-season tournament.
- League: Sanctioned and will be SIX weeks in length and will start Tuesday, September 1st for 6U, 7U, 8U, 9U, 10U, and 12U. Teams will have 12 games, which will be double headers one night a week. All Teams must be registered through www.USSSA.com before being placed on either the Pre-Season Tournament or League Schedule. *League will consist of 6 weeks of double headers. Teams may be given 1 bye week during the season.
- Rain-Outs: All rain-outs will be made up the first available Wednesday night.
- FORFEITS: If you forfeit a game, you are responsible for covering the umpire fees*
- If a team receives players from sign-ups, then you are required to play league with MGSA.
- Teams will be responsible for cleaning up their dugout, bleachers and helping to maintain MGSA. It will help if everyone pitches in and picks up after themselves while setting a good example for your children.
- There will be NO OUTSIDE FOOD or DRINKS allowed in the ballpark.
- Smoking will not be permitted inside the ballpark.
- NO DOGS allowed in the ballpark.
- League Awards for all age groups will be available in the league office and can be picked up when a date is designated. Award pick up date will be posted on www.okmgsa.com, GroupMe and relayed to the coach by League Director.
- Roster: Fill out the top along with each player's information such as their DOB, zip code and what city they live in. The city question is only to determine how many players we have from the Moore area. Please do not check anything under the parent code of ethic or scholarship box. Each parent will need to read and sign the signature roster which we will turn into the City of Moore. League Roster will be FROZEN after your second night of league games.
- BIRTH CERTIFICATES: You are responsible for having birth certificates on you at all times while playing. If there is a contest on the age of one of your players and you do not have the birth certificate, it will be forfeit.
- Contest/Protest: If you want to challenge a team's roster or player's age, you must be willing to appeal it with the UIC or Coordinator and \$100 cash. If you win the contest, you get the \$100 back immediately and the game is a forfeit. If you lose the contest. You lose the \$100.
- Background Checks: All background checks must be completed on www.ussa.com. You must complete a background check in order to be on the field or in the dugout. (If your team is REGISTERED with USSSA then you must print the coaches tab showing you & your coaches have passed the background check.).
- Parent Code of Ethics: Make copies of this form for EACH parent. Please have them read and sign this form.

- COVID: We will not be doing high fives or hand-shakes after the games. Kids will line up on the lines and wave.
 - Reminders: No “coaches bucket” for defensive coaches for 9U and up. Coaches must remain in the dugout. Coach pitch coaches must pitch from the mound with one foot remaining in contact with the mound.

- Umpires are no longer required to physically touch any equipment. Coaches will display the USSSA stamp on the bats and balls to the home plate umpire if asked. Umpires are not to address patrons. If patrons have any concerns with plays, they must be addressed with the UIC. Umpires are responsible for the well-being of the players on the field.

Parent Code of Ethics Pledge

- ☐ I will encourage good sportsmanship by demonstrating positive support for all players, coaches and officials at every game, practice or other youth sport events.
- ☐ I will place the emotional and physical well-being of my child ahead of any personal desire to win.
- ☐ I will insist my child play in a safe and healthy environment.
- ☐ I will provide support for coaches and officials working with my child to provide a positive, enjoyable, experience for all.
- ☐ I will demand a drug and alcohol-free sports environment for my child and agree to assist by refraining from their use at all youth sports events.
- ☐ I will remember that the game is for children and not for adults.
- ☐ I will do my very best to make youth sports fun for my child.
- ☐ I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed or ability.
- ☐ I will promise to help my child enjoy the youth sports experience within my personal constraints by assisting with coaching, being a respectful fan, providing transportation or whatever I am capable of doing.
- ☐ I will require that my child's coach be trained in the responsibilities of being a youth sports coach and that the coach also upholds the Parent code of Ethics.

Parents Behavior Policy

1. A parent or guardian must sign this policy which includes the parent's code of ethics before registration is complete.
2. All spectators will be held accountable under this policy.
3. Any spectator in violation of the "Parent Code of Ethics" or acting in an inappropriate manner will be required to go through the Parents Alliance for Youth Sports (PAYS) program at the Moore Community Center. This must be done before the spectator will be allowed to attend any youth sports activity at Buck Thomas Park or the Moore Community Center.
4. The PAYS program is approximately 1 ½ hours long and consists of watching a video and discussion. There will be a \$50 fee for any spectator required to attend the PAYS program.
5. Any Further violation of this policy will result in a minimum of a one year suspension from attendance of any youth sports activity at Buck Thomas Park or the Moore Community Center.
