Rules and Procedures Amendments

As outlined in Article VII of the Junior Division Rules and Procedures (Guidelines):

- **Proposed Amendment Due Date**

The Junior Division Rules and Procedures may be amended at any Annual Meeting by a majority vote of the delegates present and voting provided that the proposed amendment shall have been submitted in writing to the Secretary of the Division by February 15 preceding the Annual Meeting. - **Notification of Proposed Amendments**

The Secretary shall email a copy of the proposed amendment to all members of the Division not later than March 1 or four weeks prior, whichever is later, to the Annual Meeting (May 27, 2021).

- **Procedure to Amend Rules and Procedures**

A proposed amendment to the Junior Division Rules and Procedures may itself be amended or modified at an Annual Meeting by a majority vote of the members present provided that the modification to the proposed amendment shall have been submitted in writing to the Secretary prior to one o'clock in the afternoon on the day preceding the final business session.
