



## BOOSTER COMMITTEE OF ELK RIVER WRESTLING

### Meeting Minutes – November 9, 2020

Meeting was called to order at 6:34 pm by Seth Tribon.

- Agenda item 1: Motion to approve meeting minutes from October 9, 2020 by Blake Christopherson, second by Laura Clem.
- Agenda item 2: **Treasurer's Report by Blake Christopherson.** Financials as of October 31, 2020: Checking balance is \$21,532.36 and Savings balance is \$10,026.92. Scholarship check from the golf tournament has been addressed. One company still owes for sponsorship at golf tournament. Cost for thank you notes was paid. Youth registration money will start coming through. Blake still trying to connect with Rick Roche on insurance policy pertaining to youth. MatBoss subscription has been paid for high school; middle school is still due but undetermined if we will subscribe for 2020-2021 season yet. Bryan suggested using the HS MatBoss. Bryan and Gary C. working to determine which schools are having a MS program this year. Coon Rapids (Anoka-Hennepin) will not, however, Zimmerman and Big Lake are interested in doing a MS program.
- Agenda item 3: **Youth Update by Director, Blake Christopherson.** Open house will be next Tuesday, November 17 and first practice will be Thursday, November 19. So far 30 have registered in the Youth program.
- Agenda item 4: **Middle School Update by Bryan Kulm.** Paul Nelson has agreed to step in as middle school coach this year. Gary Lefebvre has also mentioned he could help as Stoyan is not able to do it. A Covid-19 plan is in progress. Paul plans to contact parents from last year's wrestlers. Paul to contact Community Education for gym needs, with a November 30 start date, going through January 21. Practices will be Monday through Thursday, for approximately 6 weeks. Registration will be available online; Karen to work with Paul to get set up.
- Agenda item 5: **High School Update by Coach Bryan Kulm.** High School League guidance states that 25 people are allowed in practice room at once (including coaching staff). Promotional posters have been put up. Bryan has 6 wrestlers signed up thus far. Practices will begin Monday, November 30 with the first dual of the season is set for December 11. Bryan would like to include a couple t-shirts to give out; asked if budget has enough in it. As of now, there is no State High School Tournament scheduled.
- Agenda item 6: **Old Business.** Fundraising with Snap Raise is in progress with Seth; more communication to be sent out when it's available.
- Agenda item 7: **New Business.** Event nights at the High School may not happen (youth night, Take Down Cancer night, etc). Parent's Night could be done since each wrestler is allowed two spectators at a competition. Apparel order will be finalized soon; MS wrestlers will get t-shirts (long sleeve) in place of a sweatshirt. Wrestling mats may be allowed to sell to interested families.
