Travel Fastpitch

- Jan to finalize list of player registrations that did not pay travel fee. Those players will not be allowed to register next year without paying 2021 travel fee.

House Rookie 8/9 league

- Season wrapped up in July feedback is positive overall. The one are of concern for parents is pitching at the young age, which can be difficult for kids to learn – however, overall consensus is – this league's primary focus is development, which comes from practice and game situations, and can't be taught from a pitching machine.
- Aric to retire this fall, after 10 years of board service.

Old Business:

Gleason update. Park board met with city council – outcome is that given the increase in expenses for both OMGAA and the city of Maple Grove. MG Park board is re-working final figures and will be asking if OMGAA is okay moving forward with a larger than anticipated cost than originally discussed. OMGAA to discuss and vote on updated figures once they become available for review.

IT and Treasurer position pay increase. IT requesting an increase from \$500/month to \$750/month. Discussion included that IT covers both IT duties and social media duties. Scott Ross suggested that the bi-laws be reviewed and we evaluate duties, and possibly reduce responsibility of IT as an option. It was also discussed to eliminate the treasurer pay, due to this position being easier to manage with today's software and technology.

New Business:

Dibs update / Karla Ruhr: Dibs committee has put in a lot of work to create a successful dibs program for OMGAA. Still finalizing, but Karla is requesting each director to provide their total season dibs needs/hours to Karla so the dibs committee can calculate the total number of hours needed each season for OMGAA. The dibs season will run from 12/31 – 10/31, and will include off-season dome training, which will need to be manually tracked and added to registrations (once registration opens in Jan/Feb).

September elections meeting to be held in person on September 21st at MGCC.
