- Bart Welch seconded the motion.
- No discussions
- Motion passed unanimously

#### Treasurer: Jeff Strueder

- Reports Shared in advance through USA Membership board webpage
- Presented reports that were provided in advance.
- Financial position not much has changed, numbers are as of June 21
- Total cash position provided. Budget vs actual
- Biggest events still waiting for receipts and bills to be paid.
- Income came in as about50% of budgeted membership and about the same for sanctions and charters
- Still have some lingering items that will continue to come in. Biggest deficit not nearly as many people as we had hoped.
- Discussed income from recent tournaments Cadets/Schoolboys (will be combined as we go forward)
- Junior duals credit card fees are the difference between budget and actual
- Kids' nationals' trip still have payments coming through the system
- Appears we have a pretty strong Fargo contingent this year
- Folkstyle state pretty much break-even or a little loss
- Went through financials for the trips, which are reflected on the financial reports.
- Discussed payment process for 14U and 16U.
- Jason DeLois is asking about renting, building a facility for our own use to decrease the cost of facilities.
- Discussed facilities used and how we can work on this issue going forward.
- Josh Curry is on a Greco nation team group and others talked about Grand Park being awesome.....talked about it hosting both 14U and 16U together at Grand Park.
- Jason Miller made a motion to accept Treasurer's report
- Josh Curry seconded the motion

#### **Middle School State Duals**

- Was held at The Gathering Place
- Pat Culp reported that they loved having us.
- They are now under new management
- They are just not big enough for our larger tournaments.

## **Folkstyle State**

- Pat Culp reported all in all it went very well.
- Jason Miller heard a lot about the format. Sessions were very popular and people said they
  would like to continue following that format.
- Jason DeLois reported that he heard complaints from parents who had 2 kids in 2 different facilities. They didn't like that they couldn't take the one child to the facility for the other one.

### **General topics**

- Pat Culp reported that phones can be used in weigh-ins again. USA Wrestling allows phones again, due to the fact that they are weighing in in singlets.
- Ben brought up moving elementary duals and moving to the Saturday before middle school duals. Pat asked to bring it up when we are setting the calendar. This would be regional weekend.
- Jen Ratliff stated we need to look at women and deciding how to do weights. She said we have to decide how we are bracketing weights moving forward.
- Pat Culp said it will be weight class only, no more Madison Block.
- Jennifer Ratliff said that another issue is that the women need to either have their own tournament or will they be a division of the normal state tournaments?
- She said that if it is a division in the regular tournament, there is no way to separate them out for team award.
- Pat Culp stated we need to decide as a board, do we do an individual women's team/academy award. If we do, they will need to have their own tournament.
- Jason DeLois asked about the difficulty of setting up a separate tournament. Jen Ratliff said it
  is a little extra work, but we just need to know in advance.

- Jason DeLois said he felt a separate tournament might be the best, since we are streaming all
  mats now. He feels we want to host separate tournament.
- Roby Webster moved to vote to have a separate tournament for girls for Folkstyle and Freestyle.
- Ben Nicely seconded the motion.
- Jeff Strueder asked about the ability for them to wrestle in both.
- Jason DeLois had a small handful of girls that want to wrestle both.
- Ben Nicely feels we need to have the choice either/or for Folkstyle.
- For Freestyle we run the tournament on different days. We run the women's Freestyle and Greco on the same day.
- They wouldn't be able to wrestle Freestyle and Greco.
- Bart Welch suggested for the safety of the wrestlers for Folkstyle, women must choose to participate in either the men's tournament or the women's tournament if they are on the same day.
- For Freestyle, women can choose to participate in the men's tournament as long as they are held on separate days.
- Discussed the option of boys choosing to wrestle in the girl's tournament.
- New friendly amendment made by Bart Welch: For all ISWA State Tournaments, for the safety of the athlete, each individual athlete must choose only one tournament on a given day, that they are eligible to participate in.
- Roby Webster accepted the friendly amendment.
- Ben Nicely also accepted.
- Motion passed unanimously

# High school qualifier

 Pat Culp feels we could move to a school if they continue to have it and negotiate with USA Wrestling for better terms.

# Freestyle/Greco state

- Pat Culp had people approach her wanting to know if we would be interested in hosting a Freestyle/Greco state Duals.
- Discussions around whether we want to host something like this.
- Pat Culp talked with Ryan Schilling from Trackwrestling and he can build a ranking system for Indiana to help with seeding.
- She would like to roll this out at the Annual Meeting.
- We need to identify events, and determine points that will be used.
- Need to put a committee together to determine what would be used and we can ship the information off to Ryan Schilling.
- She will put a committee together from both sides of the board and let them know before the end of the meeting.
- Jen Ratliff mentioned a concern with the minimum number of athletes on a team for team competition it dropped the number of teams for Freestyle/Greco.
- Jen Ratliff made a motion to lower the team number (minimum athletes) for Freestyle and Greco to 6 athletes to make them eligible for the team competition.
- Jason Miller seconded the motion.
- Motion passes unanimously.

#### **Central Regionals**

- Pat Culp reported we received a lot of positive comments on the location.
- Ours was the largest Central Regionals that has been held.
- We have it for 2 more years.

- Ft Wayne Coliseum is reserved for 2 more years, but can change locations if we need to.
- Jeff Strueder feels we need to clear up the entry process (coaches' bands, etc.).
- Jason DeLois said we need to specify women's division in the flyer in the future.
- Pat Culp would like to increase the number of mats to 16.

#### **14U/16U duals**

• Pat Culp reported we will need to get a list of athletes from the office for building our database.

#### Gear

- Pat Culp talked about the fact that we have had so much extra gear in the past, and have sold some at a highly reduced price at the annual meeting.
- We are now creating a spreadsheet of gear and sending to Rudis.
- Billing is separated by team which helps Jeff Strueder.
- When the gear comes back from a trip, we are passing it along to the next trip
- We will be inventorying it and ordering additional if we need more.
- We are trying to use up anything that comes back.
- Jason Miller asked if the gear being returned will it be credited to that team's trip to reduce the cost.
- 14U/16U gear came back and JD did inventory it.
- Important that if you need additional gear, let Pat Culp know for now, if you need additional gear so that we can keep track of this.
- There are 400 singlets in the garage from 2018-2019.

- Reported that we want to do a review with the team leaders from the trips to get their input from this year's events.
- Thomas Pompei has solicited information from the leaders and will combine the information into one document.
- Per Jason Miller, Jonah Odom is also working on preparing a report on the Kids' Nationals.
- We will be reimplementing some things we started before COVID hit.

- Indiana National Team Regional Training Centers went well this year. As I continue to make practice plans year to year, the plans and the implementation of the plans by our locations will improve as well.
- The scan in process (a QR code) went well except for our old school coaches out there.
- From the Sign in Sheet, we had over 1000 Coaches and Wrestlers sign in. I want to tighten that up more next year. I would like to use some of my budget to get a couple of the clubs that used the sign in sheet regularly a reward.
- I will talk to Jimmy Tonte and figure out what that looks like and bring it to the next meeting.
- All in all, it was a good year. Always room for improvement.

## Team Leader Director – Thomas Pompei

- Team leaders did a great job.
- Following up with what went well and will compile and send to the office.

## Women's Director – Jason DeLois

- 2021 ISWA Freestyle State I would like to take Fargo qualifier for Freestyle state off flier.
- There is no qualifier for the girls. Why would we limit those who want to participate?
- Despite the complaints about the way things were bracketed we experienced the highest number yet with 79 which increased by 22 from the previous Freestyle State in 2019 which had 57.
- 2021 Women's Freestyle Nationals 19 Indiana women participated in the 2021 World Team Trials in Irving, Texas.
- There were 7 divisions and Team Indiana placed Top 10 in 4 of them from 14U to U23 with the highlight placing 2nd to California in the U15 division in which we had two 1st placers a 2nd, a 4th and an 8th.
- All in all, of the 19 who went 9 of them walked away with All American status and 5 of those 9 were double All Americans in two divisions.
- And just when you thought it couldn't get any better. Those five who doubled up, 3 of them claimed a World Team spot for Team USA at upcoming high level International Tournaments by finishing 1st in their divisions.
- Those 3 are:
  - 1. Alara Boyd of Yorktown who currently wrestles for McKendree University. Alara placed 1st in the UWW Junior division at 65kgs. This will secure her spot to wrestle in the 2021 UWW Junior World Championships in

- Ufa, Russia on August 16th-22nd. Alara also placed 2nd in the U23 division at 65kgs.
- 2. Rianne Murphy of Valparaiso who currently wrestles for Region Wrestling Academy. Rianne placed 1st in the UWW U15 division at 50kgs. earning her a spot on Team USA for the 2021 UWW U15 Pan-American Championships in Mexico City, Mexico on October 21-24th. She also placed 2nd in the UWW Cadet division at 46kgs.
- 3. Julianna Ocampo of South Bend who currently wrestles for Midwest Wrestling Academy. Julianna placed first in the 15U division claiming her spot on Team USA at 46kgs for the 2021 Pan American Championships in Mexico City, Mexico. Julianna dominated the field not only pinning and Tech falling every opponent but she didn't allow 1 point to be scored on her the entire tournament.

  - 4. Heather Crull UWW U15 50kg. 2<sup>nd</sup>, UWW Cadet 46kg. 5th
  - 5. Julianna Ocampo UWW U15 46kg. 1st
  - 6. Ella Gahl USA 14U 127lb. 3<sup>rd</sup>, UWW U15 58kg. 8th
  - 7. Ysabelle Ocampo UWW U15 42kg. 4th
  - 8. Olivia Crull USA 14U 92lb. 8th
  - 9. Paislee Chambers USA 14U 136lb.
- 2021 USAW Junior Duals We were hopeful to take two teams consisting of a 14U team and a combined 16U/Junior team, but may have structured it wrong thinking the younger girls would travel on the bus with older girls. Parents of the 14U girls seemed to be concerned that their daughters would be traveling without them with strangers. If the Junior girls could travel with the boys team it would help lessen the expense of buses. Then in turn the 14U team will be responsible for their own transportation and housing which should lower their trip cost by at least \$300.
- With that being said I would like to make a motion that we restructure it this way to save money and also to encourage the younger girls and parent to go on the trip. So, I would like to make a motion that next year the junior girls team travel with the boys' team.
- 2021 ISWA Women's Fargo This year the ISWA will send 19 women to Fargo. Of these 19 we have 9 Juniors and 10 16U (Cadets). This will be the largest number of women sent to Fargo to date and I am hopeful that we will also place in the top ten as we have some very good older women competing as well as a very seasoned younger group coming in.
- As we move forward, I think it's very exciting that even though we are in the COVID ERA we are still experiencing growth which says the train is on the track and is moving full steam ahead.
- I would like to thank the ISWA for sponsoring all the women's trips this year as they have been very successful and maybe in the future, we will be able to add more trips as our women have proven themselves on a national level.

### Cultural Exchange Director – Lou Silverman

- Going to begin working on next summer's trips
- There will be 2 trips (Czech Republic in June for high school and middle school to Alaska in July).
