LEAGUE NEWS & REMINDERS

- If your team comes down with COVID and will not be attending a tournament that week, PLEASE give Shannon a call ASAP so that we can be in contact with the tournament host. Also, if a tournament gets cancelled your team will sit out that week.
- **Proper cleaning of the mats before and during the tournaments is in the interest of keeping our wrestlers healthy.** We need to do our part to keep everyone as healthy as possible to not draw attention to our sport.
- The WIAA rule for pinning out of bounds **WILL NOT** be enforced for safety reasons. WLGLW tournaments run smaller mats with no out of bound lines on the perimeter.
- Coaches will be responsible for matching colors and logos of their team uniforms. Types and styles of uniforms will be per WIAA rules. Contact information for Kim with BCI Creative is 465-9775 and www.bcicreative.com.
- Shoelaces will be either taped to the shoe or secured by a locking device on the shoe in an acceptable fashion. Rule 4.2.3 per 2024 WIAA rule book.
- Singlets are required at weigh ins.

Wrestling Eligibility

- WRESTLERS shall be ages 5 thru 14 as of **Jan. 1, 2024**. No 15-year-old wrestlers shall be allowed to compete regardless of grade level. No High School freshman regardless of age shall compete. The schools having 8th grade wrestlers competing in high school will need to designate those wrestlers on their official roster. League officers will determine their eligibility to wrestle.
- It is important to understand that on a league level all WRESTLERS, as described above, are eligible to wrestle in WLGLW league regardless of sex, ability, or disability.

Insurance requirements & fees

- League fees will be \$30.00 (\$20.00 USA card, \$10 league registration (\$9.00 to JCMT and \$1 to the scholarship fund)). (A letter from the wrestler and the head coach will be mandatory to receive a scholarship.) Team contact will receive an email with a spreadsheet to fill out.
- Coach Fee \$60/\$90 (with background check every other year)
- Tournament fee \$10.00 per wrestler except the JCMT is \$15.00.
- No spectator fees except at the JCMT.

TOURNAMENT NEWS

- Tournament Hosts- You will receive the official roster with weights on Friday Morning. If they don't appear on the official roster they **DO NOT** wrestle.
- Each tournament can decide how they want to run their bracket room (paper, track or other computer form). They will also have the right to decide if they want to have girl only brackets.
- Each tournament host will have at least one (1) **certified official** at every tournament which can be a certified high school wrestling coach.
- **League Policy** – Each club is required to have **qualified people** at each tournament to operate scorers and timers' tables.
- 13/14-year-olds will wrestle on half mat or larger. Whatever size mat they start wrestling on they will finish wrestling on.

Matches

- Rounds shall be timed as followed: 5 yrs thru 12 yrs = 1-minute rounds
13 yrs thru 14 yrs = 1 ½ minute rounds
- If a match ends in a tie, the wrestler who scores the first point(s) is awarded the win. If no points are scored during the match, it will go to the WIAA overtime format with half round times.

TOPICS

Headgear is mandatory for all wrestlers –No hard plastic on headgear and approved hair cover must be attached to the headgear.

Shoelaces must be secured – Per WIAA rules shoelaces will be either taped or secured by a locking device on the shoe in an acceptable fashion. Rule 4 article 3 per 2024 NFHS rules.

Team Singlets - Coaches will be responsible for matching colors and logos of their team uniforms. Types and styles of uniforms will be per WIAA rules. There will be no USA singlets allowed. The matching singlets help identify a wrestler to a team for many reasons such as if there is a problem, we know who to contact.

All wrestlers having braces on their teeth will wear some form of protection over the braces.

Hygiene

- Fingernails must be short and trimmed.

Bracket Room

Bracketing will be kept with-in a 5lb weight range. If using track for bracketing the range will be within 5%. If it becomes necessary to bracket over the 5lb or 5% range permission from wrestler's parents and coaches is required.

NEW INSURANCE REQUIREMENTS FOR THE COACHES

All WLGWL coaches will obtain a coach's card through the USA program. All coaches will complete all training for coaches per the USA program.

ATTENTION: COACHES, TOURNAMENT DIRECTORS, PARENTS

Any willful and / or intentional violation of league rules is expressly forbidden. **Any club found to be operating outside the league rules will pay 25% of their registration fee amount.**

Washington Little Guy Wrestling League follows the WIAA rules with a few exceptions (see attachment). The exceptions have been approved by the WLGW league and are attached.

Rule Amendments

The WLGW League follows the WIAA rules for wrestling. There are a few exceptions that we, as a league have adopted to be more compatible with kids wrestling. Those changes and the other WLGWL rules are as follows:

1. Each WLGWL tournament must have at least 1 WIAA certified official present. That person can be a coach but must be certified.
2. The length of a round is 1 minute for all wrestlers except 13- and 14-year-old which will be 1 ½ minute rounds.
3. If a match ends in a tie, the wrestler who scored the first point(s) is awarded the win. If no points are scored during the match, it will go to the WIAA overtime format with half round times.
4. Weight brackets will be in 5 lb. increments unless agreed to by a wrestlers coach and/or parents.
5. If a 13- and 14-year-old match begins on one mat section or 2 mat sections, it must remain on that amount of mat sections through the end of the match and can not be changed during the match.
6. All matches must have a coach at mat side for the duration of that match.
7. A WLGWL representative, appointed by the league, has the authority to mediate a tournament problem or issue at whichever tournament he attends.
8. No tournament jumping will be allowed. Violators will not wrestle for the balance of the season. If tournament jumping occurs on the last tournament of the season, the violator will miss the first 2 tournaments of the following season.
9. All W.L.G.W League tournaments will run in the same format as the Jason Crawford Memorial.
10. Regulation size mats are not required.
11. Wrestlers shall be ages 5 thru 14 as of February 1. No 15-year-old wrestlers shall be allowed to compete regardless of grade level. No high school freshmen regardless of age shall compete. The schools having 8th grader wrestlers competing high school will need to designate those wrestlers on their official roster. League officers will determine their eligibility to wrestle.
12. Coaches will be responsible for matching colors and logos of their teams' uniforms. Types and styles of uniforms will be per WIAA rules.
13. For the safety of the wrestlers, when they are out of bounds the match will be stopped. No wrestling will take place "out of bounds" regardless of age. Unless they are wrestling on WIAA regulation mats.
14. WLGWL allows our wrestlers to weigh in in their WIAA and team approved singlets.
15. Rule Violation is forbidden! Any club found to be operating outside of the league rules will pay 25% of their registration fee amount. The fee will apply to each violation.
