# President's Report:

We would like to invite everyone to our monthly board meetings. These are held the 2<sup>nd</sup> Wednesday of the month at 7:00 pm at the Buffalo Civic Center in the New Rink Conference Room, although this month we needed to adjust and hold the meeting online. All members are still welcome to attend the online meetings and will just need to contact Lena for the link to join.

A two-week notice to the President is requested for time on the agenda.

Currently, the rink is being painted and cleaned to ensure it will be ready to go once we get the green light to start back up. At this time, it is unclear what the activities will look like when that happens. We will use the guidance from USA Hockey and MN Hockey as well as what the state provides for what is allowed and what is not allowed. Numbers allowed in the rink as well as cleaning times in between each group are all being considered.

Jersey drop-off will be coordinated with all team managers. Please return your jerseys to your team manager ASAP.

The end of season surveys have gone out and we have received 84 responses so far. Please help us by filling out the survey so we can continue to improve how we serve you.

## **Secretary's Report:**

A motion to approve \$45,000 to cover estimated expenses for the month of April. Since there was only a partial meeting last month this is to be added to the May minutes.

### **Treasurer's Report:**

#### Actuals:

- 1. Cash Balance (from prior month): \$28,623.23 as of April 30<sup>th</sup>, 2020
- 2. Expenses paid: \$72,532.67 in expenses in April 2020
- 3. Estimated expenses upcoming: Anticipate expenses of \$14,000 in May 2020
- 4. Income received (prior month): \$28,154.90 in revenues in April 2020
- 5. Estimated income upcoming: Anticipate revenues of \$25,000 in May 2020

In the month of February we had an error on our financials. We worked through this error with CLA to identify and correct the problem. A deposit in the month of February was included in our general ledger twice due to an error with automated account reconciliation.

As a result a motion was made for \$30,000 from Gambling to correct the error.

• Ryan 1<sup>st</sup>, Mike 2<sup>nd</sup> No Discussion. All approved and motion passed (8-0).

Due to the current situation, we understand that next year could be tough financially for the association. The BOD will need to prioritize expenses to ensure that we can run a successful season. Things such as, but not limited to; warm-ups, new jerseys, summer program sponsorships, SCORE, TEAM, 5,000 Puck Club are all being looked at. The BOD also plans to discuss with the City of Buffalo what accommodations they can assist with.

As we start the process for budgeting for the 2020-21 year we will need to be mindful the lost revenue from the gambling association as bars will be closed for at least 75 days. This will result in the association needing to find cost savings for the next fiscal year.

A motion to approve \$3,500 paid to the Ice Scheduler for the 2019/2020 season.

- Ice Scheduler


Ice-In Party is planned for September.


