- 1. Public Comments: None at this time.
- 2. Executive Committee Reports
- a. Secretary Carrie Biggin: reported that previous Secretary minutes will need to be voted upon in an email vote. Edits need to be made to the previous meeting's minutes yet.

- c. President Elect Tara Freund: presented an overview of the Brewers concession opportunity coming up. The Sign-Up Genius is almost complete and ready to go out for members to sign up to help. Online training info will come out via email and must be completed. We currently have a list
- d. Past President Suzanne Doody: reported on the most recent SP-ICE meeting, OBHL is about done. Both sheets of ice will be coming out and redone, at different times. There will be DIBS opportunities for painting hallways. SP-ICE offered a discounted foursome rate for the Zamboni Open, is there any interest? One raffle prize at the outing will be ½ off registration fees.
 - e. President –Eric Seidl: reported on Steve's attendance at the annual WAHA meeting, change in new penalty minutes being assessed for the year; Squirts penalty minutes will now be 1:00 min, Pee Wees and Bantams will be 1:30. Due to MyHockey rankings, the previous rule where all Region 4 teams had to play one another twice, is no longer in effect. There also will no longer be a Region 4 scheduling meeting due to these online ranking systems.
