## Old Business

- Spring/Summer Update - Tommy

## New Business

- Facility Vision - Brent
- Brent presented overview of what P.L.A.Y. facility could look like conceptually/directionally. A few different option to consider including dome type structure, an indoor facility that could house 2 full size basketball courts or some other type of indoor space.
- Options to find land and build vs. identifying an existing property Ideally would serve large number of sports in variety of ways
- Talk with school district about potential Grainwood football field re-development
- Formation of sub-committee - Justin, Brent, Shreve + others to conduct initial research into feasibility


## New Business (cont.)

- Individual Sport Workflow Requirements - All - What are events/processes/etc. that all sports need to include in their typical yearly workflow? What are things the Executive Board expects all sports to execute on? Results of dialogue:

Sport AND Team Level Meetings for Parents required Pre-Season Coaches Meeting required

- Each sport needs some connection/liaison to the HS program
- Required to publish Board meeting dates and notes on website
- Minimum 6 sport board meetings/year required
- All team selection/player draft process require Exec Board review/approval
- Any variation from standard processes during team selection requires approval from disconnected Exec Board Member (someone without an athlete in that sport)
- Number of roster spots per team within a sport should be standard; Variations from that standard require approval from disconnected Exec Board Member (e.g., baseball/softball 12 per team, basketball 10 per team, etc.)
- Anti-Bullying information/content required to be delivered pre-season at sport level and pre/during season at team level
- Equal opportunity must be offered within each sport in regard to facilities/fields. (Example - if multiple fields are used for a grade level, the teams should have equal access to all fields by sharing/rotating use.)
- Equal opportunity must be given within each sport in regard to access to equipment and resources
- Sports must be courteous to all other sports in our organization (and secondarily to be aware of other LAA member orgs) when it comes to tryout dates, season start dates, clinic dates, etc.
- A full list of sport expectations will be voted upon at Annual Meeting (Jan 2023)
- Sport VPs/Directors will be invited to February work session to provide input on two things:
- Facility Needs - each sport should present their "wish list" for a facility (e.g., square feet need to accommodate their space, equipment needs,
- Team Selection - each team will have 5 minutes to present overview of their team selection process, including ideal \# of roster spots per team - for Exec Board initial approval
