# Registrar's Report - 4 December 2024 Meeting

➤ There will be two new players joining our Association at the U7 level between now and the New Year.

As per Hockey Manitoba's new process of monitoring certification deficiencies within the Associations, The Pas MHA was identified as having twelve (12) Coaches, Bench Staff, etc. that were lacking the proper certification, in order to be eligible to be on the bench etc. Emails and reminders were sent out to the individuals prior to the deadline date. As of the deadline date (1 December) The Pas MHA has five (5) that still require proper certification. Hockey Manitoba has marked their profiles as INELIGIBLE, with their respective teams. (Some are certified for the lower teams that only require Coach 1 but not for the teams that require Coach 2 certification.)

Once they complete their certification requirements, their profile(s) will update itself and they will be shown as APPROVED.

In regard to our Volunteers etc. that have yet to return their *RCMP*Criminal Record Checks (CRC) there is at least ¼ of the Registered

Coaches, Bench Staff etc. that have yet to return their CRCs. This

would be in direct violation of our previous and current

Constitution Article.

Please review the fundraising policies or speak with any of the Executive Board members if you require any clarification.

Also, as per the Constitution and By-Laws of The Pas Minor Hockey Association (TPMHA), Section 4 under Colours, Logos and Apparel, all Huskies-related apparel produced for members and/or players must be approved by the Executive and meet the policy guidelines, as well as use of the Association's logo (image and/or names), including but not limited to "The Pas Huskies" must be approved by the Executive. (An official logo will be kept on the website for submission to sanctioned travel tournaments or home game/tournament usage).

At the conclusion of the fundraising activity, the team will submit the "Funds Earned" report to the Fundraising Chairperson (s). The Fundraising Chairperson (s) will submit the report to the Executive Treasurer.

Appropriate uses of fundraising monies include, but are not limited to:

- Payment for extra practices or games not included in club fees
- Team building activities
- Player end-of-season gifts (this requires approval from all team members)
- Coach end-of-season gifts

All team members must be in unanimous agreement to the use of the fundraising monies. If there is a discrepancy, the Team Manager will have final say.
