

Arizona Region of USA Volleyball
Junior Boys Tournament Contract
2025-2026 Season

As the official Club Representative for the club listed below, I hereby agree to the following terms and conditions for my team(s) to participate in the 2026 Junior Boys Power Tournament Schedule of the Arizona Region.

The following terms are hereby understood and agreed upon:

1. **This signed contract should be submitted with the Team Registration and Seeding forms no later than September 11, 2025. The tournament fee of \$1300 is due and payable in 2 payments. The first payment of \$650 is due with registration materials by Sept 11, 2025. The balance of \$650 is due by Nov 14, 2025.** All late payments are subject to \$100 late fee. The contract fee is per team and includes the team registration fee, entries into 5 Region power tournaments plus the Region Championships. Contract payments made with a credit card will incur a 3.5% handling charge.
2. **Formats:** The Divisions will be made of 8 teams per Division, where able. All 15s-18s teams are mixed for play in this Division. The 14s will be placed in their own Division due to net height differences. Tournaments are all day tournaments. Format will be pool play followed by a single cross pool match - 4 matches/team/date. Teams will play in their respective age division for the Region Championships. The Region Championships format will be pool play plus bracket play for place in each age division.
3. **Code of Conduct:** Failure to abide by the USAV Code of Ethics (refer to membership application and Parent/Spectator Code of Conduct) will disqualify the violating team, violating team members, and violating team coach(es) for one calendar year. Unruly parent/spectator behavior is to be corrected by the club first; then by the Arizona Region Ethics and Compliance Committee. Falsification of age or identity will result in a 2-year suspension in membership opportunity for the player, coach, club director and/or the club involved.
4. **Rosters:** Every member of each team (player, coach, and team rep) must be a current member of the Arizona Region/USAV with all requirements for the membership completed before participation in any tournament or practice. A printed, signed, current roster, showing eligibility, must be submitted at the team check-in for each tournament.
5. **Referee Assignments:** Part of participating in Arizona Region tournaments is the referee assignment. Teams will have their coaches and players trained in scoring and referee disciplines annually to be competent in their required duties. It is also required that teams fulfill their referee assignment for every match to keep our tournaments on schedule. Teams that refuse or leave without fulfilling their referee assignments will be fined \$100 and removed from further tournament schedules until the fine is paid and an understanding of their responsibility is accepted. For all teams that will travel, it is strongly recommended that the coach, Parent Official or other "rostered" adult, R2 at least 1 match per tournament to remain proficient for National Qualifiers and Junior National Championships. For matches that a coach or other rostered adult is the R1, the club will be credited \$24 per match officiated. If the coach/adult is a certified referee and officiates matches on days when his team is not playing, they will be paid match pay **through their Arbiter account** equivalent to their current rating in lieu of the club being credited. If the coach/adult is not a Region official that is paid in Arbiter, the club will be credited for the match.
6. **Non-Refundable Fees:** These monies are non-refundable. Any no-shows or forfeitures by a team prior to a tournament will result in the team(s) surrendering the tournament entry fee to the Arizona Region. Forfeiture also equates to a last place finish in the tournament, and as such, forfeited team(s) will be placed accordingly for the subsequent tournament.
7. **Tournament Commitment:** It is further agreed that a commitment to play in the power tournament schedule is strictly voluntary. Therefore, failure to show or notify the Tournament Director of non-participation at minimum of 48 hours prior to the tournament will result in my team(s) being fined \$100 per non-participating team. If my team(s) fails to show or notify the Tournament Director of non-participation for two tournaments they will be banned from play in the Arizona Region Junior Boys Tournament schedule for the remainder of the 2026 season.
