President's Report	Kelly Traynor	<ul style="list-style-type: none"> Membership was informed that proposed Bylaw changes will not be addressed at the Annual Meeting, as they were not posted for the required 20 days per CRYHA policy. A vote has been rescheduled for the regular Board meeting on 4/27 at 7:00pm. CRYHA will co-op with SLP at the Pee wee and Bantam levels for the next two seasons. <ul style="list-style-type: none"> SLP has requested Coon Rapids players participate in their STP to help players become more familiar with each other. Coon Rapids will still offer its own STP, now expanded to three sessions instead of two. A member asked if new helmets and gloves would be required; no decision has been made. A potential three-way co-op with CRYHA, Champlin, and Anoka is being explored. D10 is awaiting responses from Anoka. A meeting between the three associations will be scheduled to discuss further.

Despite rising vendor costs, finances are tracking similarly to last year. With four months left in the fiscal year, projections indicate a strong financial position heading into the next season.
