#### 15U Bantam AAA

- Provincial berth distribution has been set. Tier one 4 + host, Tier two 3, Wildcard 2. Inter-tier weekend set.
- Logistical challenges based on uneven tiering number (8 and 7 teams).
- Resistance from Chilliwack and Kamloops not wanting to travel and play each other as they are already in the same tier and will play each other four times in regular season play. Discussed at length and will grant them the weekend off.

#### **Communications**

 Recommendation for designated "correspondent" at special events such as the Team BC development camps, Coaches Caravan, and others so that we can get more consistent and thorough promotion out to our member associations, membership and general public.

#### Website

Some technical challenges with the back end and accessing certain areas. Discussion at length with John
Braaten will be looking at alternative for the future as frustration with TeamPages seems to be mounting
and recurring.

## **Coach Development Report**

Follow up email scheduled for registration to host coach training.

#### **High Performance**

- 13U and 15U Development camps complete.
- Team BC for both have been selected. Working closely with Cam Frick to advise and inform parents and players of next steps.
- Positive feedback being received from both events.

#### **Marketing and Sponsorship**

- Project with Traveling Teams has been progressing consistently and Marketing committee has reviewed proposals. Traveling Teams presents a substantial solution and revenue stream in providing the accommodation management for BC Baseball events, specifically the Provincial Tournaments.
- Requested contract for final review and authorization as lead time to put appropriate relationships with lodging properties is approximately 9-12 months.

- There is no cost to BC Baseball, all lodging logistics are managed by Traveling Teams and rates are guaranteed to be the best available online rates.
- Projected revenue is conservatively estimated at \$50K which will help offset our current annual spending deficit.
- Additional perks and comps to be negotiated on a per case basis.

#### 7.7 North – Carmen Martin

- The spring season is now underway in PG and Quesnel.
- Summer season declarations have been submitted, and hoping to add a team in the not so distant future at the Mosquito A level.
- We had 2 players in both Mosquito and Bantam from Quesnel that were given tryout releases for our summer season tryouts and it appears that 3 out of the 4 will require player movement forms to be completed- nice to see the interest from Quesnel in playing with PG for the summer.

#### 7.8 Interior – Terry Chudyk

- On 29 th May held a Summer meeting (conference call) for the Interior Associations. In attendance for the
  conference call were COMBA, Vernon, Salmon Arm, Kamloops. Absent was Princeton, Osoyoos, SOMBA,
  Summerland, West Kelowna and Revelstoke. We covered some of questions in respect to rules, summer
  team possibilities, zones and questions in general about baseball. I also brought up the fact that we're still
  looking for an additional Interior Director.

## 8.6 Eligibility – Pat Weatherill

- 206 Spring Tryouts
- 141 Spring Releases
- 43 approved move ups......although probably more out there as some do not know about receiving approvals from BC Baseball
- 26 approved move downs.....same as above
- 22 Try out requests for Summer......mostly Pee Wee AAA from associations not declaring, and Midget AA as some associations not able to field
- No Summer release as of yet
- Penalties assessed to Delta Tigers Bantam AAA, North Island Bantam AA, Salmon Arm Pee Wee, White Rock Bantam AA, for various issues involving rosters, with NON-approved player's.....each has been dealt with on an individual basis. Continuing to look through the rest of the information provide, and will speak to those whom are non-compliant.
- Going forward, we will need to further educate association's on rules and how they are applied.
- Concerns voiced around the trend of associations making the determination when eligibility rules apply and the impact of this approach on players and other teams
- In determining fines and suspension Pat Weatherill can bring before the board as he deems necessary otherwise he will determine the severity and form of fines as suspensions at his discretion
- BC Baseball stands by the process and the mandate to administer rules as they apply
- Fines and suspensions are assessed on a case by case basis
- A request was put forth by Powell River to allow their spring AA team 35 of their 45 registered players are first year players. Permission granted by Pat Weatherill.
- Request from North Delta in regard to eligibility of one player. Upon further review question of eligibility
  has been managed in accordance with BC Baseball rules by North Delta.

## 8.7 Umpire Liaison - Eric Toneff

- Contract signed and sent
- Three man system budget requested by BC Baseball from BCBUA, not received as of meeting of the board

- A couple of member associations not carding umpires, based on resources not being there. Eric will respond to BCBUA and will follow up with those associations to investigate
- Incident of official not assigned to game (UIC for home association) entering the field of play and reversing
  a call. Request made for BC Baseball to address, discussion, it is the position of BC Baseball that the UIC is
  designated by association, therefore it is the responsibility to govern the behaviour of their UIC.
- BC Baseball on April 3 inquired from BCBUA all new 2018 rule changes from Baseball Canada related to umpiring. BC Baseball had previously received this information from BCBUA back in January to which our board had simply forgotten. BC Baseball circulated the material to its board, but fell short of processing the items.

## 8.8 Discipline - Eric Toneff

- Aldergrove Jr. Mens Letter received from association outlining their position in regard to role of BC
  Baseball in governing the assessment and application of any disciplinary actions. It is the view of
  association that this is not under the umbrella of BC Baseball but in fact the responsibility of the home
  association to investigate, interview and implement ruling. It is the view of BC Baseball as the governing
  body to act as a neutral third party to review in an unbiased framework and administer any appropriate
  sanctions as deemed necessary by the reviewing director(s).
- North Shore Parties in question has requested to speak directly with Mike Sarai. Mike will connect with them and report back
- Chilliwack Appeal received, appeal fee outstanding. Appeal will be heard upon receipt of appeal fee. Mike Sarai allows appeal to be dealt with.
  - Discussion around extenuating circumstances that impact the behaviour of parent involved in the incident. Consideration given to overall impact on other parents and players including letter received from coach team appealing.

#### 9. Division Reports

## 9.1 11U - Grant Butler

#### 11U Summer Ball

- Many Associations are still putting teams together and the declarations are coming in, the deadline being June 15, Rule 9.03
- The summer ball meeting for 11U is scheduled for 2pm, June 10 at Cloverdale Clubhouse.

#### 11U A Provincial Host Re-designation

• On May 22, Valerie McCullough, New President of Campbell River informed me last week that they would not be able to Host the 11U A Provincial Tournament as they would not be fielding a 11U A team this year. I did discuss this with her and found while they didn't have a team last year also she didn't know why the decision to host was made. On Saturday, May 26, Val sent out a mass email to all presidents and the same was posted to the website message board. I received interest from Oceanside, Nanaimo, North Delta and some others I encountered at the John Main Tournament. On May 27, I received a call from Chris Lund, President requesting and confirming that they would Host, to which I accepted due to the urgency of having a Host.

### Request from North Shore to play down from 11U T1 to AA

- Was received and through discussions with NS the request was revised to play down at the 11U T2 level subject to evaluations under Rule 9.04(A)(vii). The reason/feeling of NS was that their players would not be able to complete at the T1 level and wanted a positive summer experience to build their program. Upon reviewing current play registration we find NS has 111 players and last year with 109 did field T1 and AA teams, so our initial review would be that NS should be able to field a T1 team. Nonetheless, we agreed to do the evaluations.
- Grant Rimer, BCBA High Performance Director, accepted my request to watch an MSET game in Cloverdale while Anne Hayes, BCBA Director and myself watched two (2) NS home games that involved all 3 of the teams in the AL Tier (Top Tier) of the NS 11U program. After discussions with Grant Rimer and reviewing what Anne and I observed we found that the NS level of play was at a mid to late season level for 11U. The players were athletic and able to make the most basic plays while putting the ball in play while up to bat. The coaches were supportive and informative during the game while observing general playing rules including wearing catcher's masks while warming up pitchers and ensuring chin straps were in place. The level of play of these Tiered teams was significantly more sound than the level of play we watched recently at Duncan who do not Tier and play prospects with a revolving roster.
- As a result from our evaluations and discussions the request to play down from the 11U T1 level to the T2 level for the 2018 summer season was not approved. The reply from NS was not only disappointment but a suspicion that they will not be forming any 11U summer teams.

#### North Langley, Request to Field 11U AA ahead of 11U A

• North Langley, having 87 registered players in 11U this year and only 24 - 30 players trying out for summer ball, requested to field the required 11U AAA T2 team under Rule 9.04(A)(v)(a) and then a 11U AA team instead of the required 11U A team. The reason being is that North Langley does not have enough first year players (10) to field the 11U A team and they wish to field as many players as possible and create more interest in summer ball in the future and give the proposed team and those players somewhere to play. Also, North Langley has inquired with their neighbouring Associations and do not find a good fit for these players at this time. The 11U Division supported this request for the 2018 summer season and granted approval.

# 9.2 13U - Anne Hayes/Sanda King/Steve McCann

- Provincial Directors coverage assigned and confirmed for A/AA/AAA
- Discussion around Provincial berth allocation at AAA level. The current path distributes eight berths to
  lower mainland, host and Island. This leaves two berths remaining with one automatically designated to
  the Northern region resulting one remaining spot to be determined through wild card tournament.
   Recommendation is to increase tournament to a twelve team format. Will reach out to host association to
  discuss and confirm logistical ability

# 9.3 18U - Grant Rimer / Les Szabo

- Surrey and White Rock have requested motion to merge in order to field 18U AA Summer team.
