 - a. **Monthly Financial Summary:** Our checking account balance as of 02-28-23 is \$66,550.25. Our balance on this date last year was \$157,687.39. Significant revenues since last meeting include travel registration payments (\$19,600.40); House/MDP/LTS registration fees (\$8,172.50); Christmas Tournament income (\$4,585.50); and uniform payments (\$422.38). Significant expenditures from the past month include ice rentals (\$42,275); skills sessions (\$2,205); referees (\$1,959.50); on-ice supplies (\$148.72); uniform purchases (\$135); storage (\$135); and meetings (\$81.83). Looking ahead, we're anticipating \$60 to \$65K in revenue in March from outstanding payments for current season registrations (~\$5K), the return of the SG security deposit (~\$23K) and team selection evaluations (~\$35K). Combined with our current balance, we'll have about \$125K to cover expenses from February 1 (invoices will arrive this week) through the start of next season in September.
