### **President's Report (Rick Nuss)**

- Formation of committees: Budget, Bylaws & Policies, Coaching, Fundraising, Player Development, Parents Meeting & Website: will help to streamline meetings.
- JV is playing in the Pumpkin Tournament, Parents took it over. Cost was \$1100, or about \$60 per kid
- 14u ended up 4 in 2. The last weekend they came up shorthanded against two tough teams. At the half against Minnetonka they were 2-2, may have kept it close if they had more legs.
- Rick and Craig are going to write up emails to the coaches. Start doing annual player evaluations with 14u, especially 2nd year. Give them things to work on as they get out of youth and into the school. Talk to the kids before box, send email out to the parents.
- Rick is meeting with Bill Carter to bounce some ideas off of him and talk to him about acting as a Coaching Director. Bill played at UMD Lacrosse.
- Recap on Boosters vs Youth. Do we keep doing as we are doing or anything over 14u goes to them? Revisit at a later date.

### **Treasurer's Report (Katie Schmidt)**

- Everything is up to date and reconciled
- Will try to consolidate accounts according to the budget.

- Income/expense report- Coupon book \$620, Golf \$3,717. Total fundraising income was \$4,337. Registration income for fall u14 & u16 totaled \$4,470. Total of income categories was \$7,156. Apparel- sponsor shirts \$1120. Total bank charges \$95. Paid for 2 lacrosse memberships \$110. Storage facility rental \$210. Field equipment \$1,392.65 for Fall uniforms, part of the JV registration.
- 18u girls summer team refunds -\$1,651 was girls refunds. Some girls signed up early, it was then thought they weren't going to have a team so they were refunded. Check to Ed for \$2,351 for 3 coaches. Tabled for next meeting
- Expenses- Golf expense \$960. Jersey refund \$65. Marketing \$5,599, Registration fees \$1,652 went out, Balanced through the bank as of the last statement \$14,825.24
- All that's left is Field rentals through Community Ed for Fall
- Wrote a check to Mike to pick up \$200 gift card for Scott, for coaching JV

## Fundraising - (Lorinda Ims,) Rick Nuss discussed

- Golf tournament made about \$3700. 1st & 3rd place gave their money back which was about \$800. Gayle has more information about that.
- Next year looking at only doing 9 holes instead of 18 and doing 2 teams per hole, giving us about 18 teams that we would try and get registered. We made about \$20-\$25 per golfer. People thought it was the cheapest they had seen so we might be able to raise it to \$75 per player.
- In the future do more to advertise and get it out there sooner. Request more sponsorships. Push into our fundraising committee. Put different classifications on it Sponsor a hole for an additional \$. Possibly get it out there by the end of the year since companies may need the tax deduction.
