Important Details:

- Regular Season starts **Sunday May 28 @ 3pm (Pending weather/fields conditions etc.)**
- Registration spots are limited 1st come 1st serve (open age group, 18+ men's league)
- Teams require a min. of 15 players; a maximum of 18 players dressed per game and max. 25 players on the roster sheet
- All rainout & rescheduled games will be re-played on Friday nights 2 weeks after the rain out date (no long weekend games)
- **Regular season includes 14 games guaranteed, plus top 4 teams in each division enter PLAYOFFS**
- The League reserves the right to balance out any and all divisions accordingly along with any and all schedule changes without teams/player's approval.
- League includes website with team pages, team logos, stats, schedules & news
- Teams must supply their own uniforms with NUMBERS on the back
- \$500 Deposit due with application (refundable ONLY if the league or division is not viable)

Team & Individual Awards:

- Division Team Winners (after 14 games) receive \$500 cash & Team Trophy/ Cup
- Playoff Winners per division will receive \$350 off next summer's Registration and Team Trophy/ Cup

Extra Costs for all DIVISIONS:

- **\$40 online Player registration fee per player**, max roster 25 players (max 18 players dressed/per match)
- **Ref fees not included, will cost \$70.00 per game**; to be paid at the field before each match (Incl. one Ref and two linesmen) - \$140 combined from both teams to cover all 3 refs each game.
- **\$300 CASH Security Deposit/ Bond per team REQUIRED** – to be used for player/team fines, fees, red cards, no-shows etc.
 - **Red cards \$100.00 fine** to be paid before the next Match (using security deposit)
 - **“No-Show” Default Rule** – cost **default team \$140 to cover ref fees** for both teams, plus 3-0 game LOSS
 - **CREDIT CARD** will be filed if/when the Security Deposit (\$300 cash) is used up. If you have no penalty or fines – you will get the full \$300 cash back to your team end of the season/ playoffs.

I, the undersigned, as representative of the team and all its players, acknowledge that Versus Soccer League, soccer governing bodies, and their agents are not responsible for injuries that may occur in the course of outdoor soccer games organized by Versus Soccer League and/or sanctioned Glen Shields SC Furthermore, I hereby clear Versus Soccer League and it's agents against any liability in the event of injury to any of my players, and damage or theft to my team's possessions or personal property that may occur on facility premises and other outdoor premises before, during or after league games. VSL reserves the rights to all photos/videos taken before, after, or during all or any games within the VSL. As Team Representative I am taking full responsibility on signing and agreeing on behalf of my players.
