

SPRINGFIELD JR THUNDERBIRDS FINANCIAL CONTRACT HALF YEAR TEAM

My/Our child, _____ has been selected from a tryout process to play for the Springfield JR Thunderbirds half year team. As the Parent(s) and/or Guardian(s) of the above-named player, I/We agree and accept the following terms and financial obligations within the contract.

The terms of this agreement are as follows.

The total tuition is Two Thousand Six Hundred Dollars (\$2,600). I/We, the Parent(s) or Guardian(s) (hereinafter known as Payer(s)) of the above-named player agree that the full tuition obligation is incurred at the time this contract is signed and that tuition payments are not refundable for any reason. I/We, the Payer(s), hereby waive any claims that we may have that the full tuition is not due, or that any part of the full tuition is refundable.

You may pay in full (\$2,600) at the time of commitment using your preferred payment method. Checks are payable to Springfield JR Thunderbirds.

If you do not pay in full in advance, you may enter into an installment plan, the terms of which follow. The Parents and/or Guardian(s) hereinafter known as Payer(s) of the above-named player, agree to make tuition payments in the following amounts: a payment of \$1,300 to be paid and delivered along with this signed contract. This \$1,300 is non-refundable. This payment reserves your player's spot on this roster. Failure to make this payment in a timely manner could result in the loss of the roster spot. After the initial payment, a final payment of \$1,300 will be due and payable on June 1 for a total tuition paid of \$2,600. The commitment payment of \$1,300 must be made through the Springfield JR Thunderbirds online website's payment portal www.juniorthunderbirds.com. The subsequent \$1,300 installment will be auto-debited using the same payment method used for the initial commitment payment. The auto-debit will be drawn from your payment method on 6/1/2026. You may be responsible banking penalties charged to the Springfield JR Thunderbirds if any scheduled auto-debit fails. You may be charged a \$100 per week late fee if any scheduled auto-debit fails. All players must be paid in full by June 1. After this date players will not be permitted to participate until full tuition is paid.

All tournament fees and uniform fees are included in tuition.

I/We the Payer(s) fully understand and agree to accept that game ice-time will be determined by the coaching staff based on, but not limited to, traits such as character, talent, discipline, and hard work. I/We the Payer(s) understand, and agree, and accept that there may be other expenses and costs associated with my/our son/daughter playing for the Springfield JR Thunderbirds team, which are not covered by or listed herein on this financial contract, including but not limited to equipment, fuel for your vehicle, meals hotels, tournament expenses, etc. and I/We Payer(s) assume, agree and accept any and all additional costs.

I/We Payer(s) understand, agree and accept that if My/Our Child's association with the Springfield JR Thunderbirds half year team is temporarily halted by injury or suspension, or is terminated for any reason from the date of execution of this agreement that I/We Payer(s) will remain responsible for continuing to make any outstanding tuition payments and otherwise fulfilling, paying and abiding by the terms of this contract.
