# NCYHA Minutes (3/3, 6:30 PM)

## **Virtual Zoom Meeting**

#### **BOD Votes**

1. Obtained approval of 2/10 meeting minutes, sent to Sarah/Jeff to post on the website:

#### **Outstanding Action Items**

- 1. COMPLETE Aubie Sent letter to organization outlining open positions up for re-election (president, treasurer, house league, learn to skate, MDP, Squirt & Bantam level directors). Level directors need to be in place by the end of March in advance of tryouts.
- 2. IN PROCESS (Do not need to track here) Jeff Day/Sarah/Chris In the process of webmaster transition, will meet with new sports engine account manager in future. Jeff has full admin rights to the website.
- 3. IN PROCESS Brian Torello Provided strategy for refraining from using pinnies for tryouts in 2021 due to COVID. Suggestion for this year would be players wear their game jerseys, practice jerseys (w/ numbers taped to the backs), or are assigned a pinnie. This strategy goes against the anonymity that was created using pinnies to ensure fair evaluations for players.
- 4. IN PROCESS BOD -Strategize candidates to fill open positions. Aubie, Bryan and others are in talks with candidates for outstanding positions.
- 5. Aubie Request for reimbursement for background checks from RI hockey (\$20/coach)
- 6. BOD Will vote in coming week on Team Genius software/app. Designed for evaluations, replaces pen and paper in a rink, highly customizable. Evaluations can be completed seamlessly on phone via app. \$5/player annually (groups of 50 players) =\$750/year to implement for tryouts. Can provide mid-season analytics to parents. App has a methodology to hide players' names to allow for anonymity. Aubie/Chuck to provide additional information via email to BOD.

#### **Board Updates**

- 1. President Update
  - a. RIHockey
    - Concern around players moving programs and having outstanding balances to programs they are leaving
       looking for a policy to prevent this from happening in the future.
  - b. SCHL
    - i. Voted for next season to have 15 minute periods for Squirt A and Pee Wee A; 12 minute periods for SquirtB/C and Pee Wee B/C. They did not consider players moving from Squirt A to PW B, etc., TBD if they will reconsider.
    - ii. Voted against allowing those RI club teams that requested into the organization.

- iii. Planning to have quarter and semifinals for all teams, during the last week of March. Finals 3/27 & 3/28. All organizations will be asked to split the cost of ice/ref fees for playoffs.
- iv. All coaches must have a copy of their USA Hockey roster to be turned in with every game sheet.

#### 2. Treasurer Update

- a. Discussed 2020/2021 refund/credit for travel players due to surplus in budget. Proposal loosely agreed to (Brian Clark will review numbers and we will take vote via email in upcoming weeks):
  - i. In lieu of direct refund, NCYHA will purchase 2 travel away jerseys, 2 pairs of socks for all travel players (Bantams will continue to use numbered, reversible NCYHA issued shirts that are reused each year). TBD if shell pants can be covered in the proposal.
  - ii. Players that are not returning will not receive a refund
  - iii. Players moving from Bantams to Midgets will receive a credit applied to midgets, TBD amount

#### 3. Scheduler Update

- a. Comprehensive skills sessions with overspeed scheduled for later this week. TBD the plan is to keep teams separated for COVID. Brian, Aubie & Toby to discuss.
- b. Exploring options for tryouts (looking for ice where evaluators will be allowed) league requested team counts by 6/15
  - i. 3rd week of March (3/15 3/17) at PAS (no spectators allowed, TBD how we will bring in evaluators). 3/15 starts RI public school middle school sports.
  - ii. Boss Arena in April with 25 total in the rink (players & coaches). No evaluators allowed
  - iii. Need to find venue where evaluators allowed and ideally more than 25 skaters
- c. Need to confirm with St. George's that they are planning to allow outside groups to use the ice October 2021

## 4. Registrar Update

- a. Outstanding payments:
  - i. 2 invoices for missed tryout fees
  - ii. 8 installment payments
- b. Tryout deposit amount will remain \$200, non-refundable
- c. Ella Silva requested a credit for the season. She is a midget that was injured before the season and was not able to play. BOD approved providing a credit for next season.

  - a. BOD decided to move forward with Verbero for travel uniforms (at least Mite Pee Wee).
    - i. Need to work through details Ex. how will orders be handled, desire 2 color practice jerseys, etc.
