Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Essentia Health Sports Center and Girls Summer Training Program (STP), have put in place preventative measures to reduce the spread of COVID-19; however, The Essentia Health Sports Center and Girls STP cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending a Girls STP could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Girls STP and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to, or infected by, COVID-19 at Girls STP may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Girls STP coaches, Essentia Health Sports Center staff, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance and participation in Girls STP ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Girls STP, it's coaches, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Girls STP, its coaches, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in Girls STP.

I understand that hockey is a game of risk, with the possibility of serious injury or death. I do not hold Girls STP, John (Jack) Freeman, other STP coaches, Essentia Health Sports Center and their employees liable for such injuries in my child(ren)'s participation in this program. I also verify that I am insured and that my child is insured through my healthcare provider. I also understand that any fees paid will be non-refundable after May 7, 2021, including Covid-19 unexpected shutdowns. Registrations for Girls STP 2021 are at your own risk.
