- Treasurer report
 - Fees need to increase, except for rec fees
 - 10% coaching budget increase
 - Facility/dome rental increase of \$10,000
 - Marketing budget increase of \$1500
 - Coaching – changing landscape leads to us needing to spend more
 - Trying to get time at other domes just in case
 - Marketing – reach out to other clubs, don't sit back
 - Community rental fees
 - John Janke is new facilities manager
 - Rates very likely to increase significantly from previous years
- Rates for 2018-19
 - \$50/session futsal, or \$100 for all 3 - C3 only
 - U9/10: go up to \$550 (from 460)
 - U11/12 C1: go up to \$670
 - U11/12 C2: go up to \$610
 - U11/12 C3 (no futsal): go up to \$505
 - U13+ C1/Premier: go up to \$720
 - U13+ C2: go up to \$665
 - U13+ C3: goes up to \$565
 - U19: goes up to \$500
 - Nov/Dec training for C2: \$60 (from \$45)
 - Motion to approve 2018-19 rates as proposed: Josh Forsythe, Chris Lewis 2nd - unanimous
- DOC update
 - Went over DOC report
 - Tryouts – marketing push
 - Esperanza – Jesus working on getting teams to end-of-year event
 - Discussed competitive landscape
 - MYSA v TCSL – putting younger teams at TCSL, older teams at MYSA
