This form must be completed and signed by the designated official in order to be valid for each level of play. This form is considered a credential necessary for tournament play. **Consent for Treatment forms** are required for the first level of competition. The photo and your sign up online will help host sites from State play to the World Series have your team’s information for the program books and online scoring. Also, this will help with the Headquarters staff to contact the Team Manager for World Series Travel. No World Series Travel can be booked unless this online form is completed.
