RELEASE OF LIABILITY WAIVER

In consideration of being allowed to participate in any way in the HHGFA Programs and tournaments, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

a. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death. While rules, equipment, and personal discipline may reduce this risk, the risk of injury does exist and

b. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and

c. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and

d. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE and HOLD HARMLESS, HHGFA, their officers, officials, agents and/or employees, coaches, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

e. I have read and agree to abide by the HHGFA Concussion Protocol and understand that all suspected concussions must be reported to the President of the HHGFA by completion of the HHGFA suspected Concussion Report Form within 14 days of the accident. Return to play and medical documentation must be submitted to HHGFA prior to the participant returning to the field of play. Permission to play will have to be approved by the HHGFA Board of Directors.

f. I understand that all accidents/injuries must be reported to the President of the HHGFA by completion of the HHGFA accident report within 14 days of the accident. The injured party has 30 days from the date of the accident to initiate a claim with HHGFA and be received by the insurance company.
