- 2. Executive Committee Reports

- a. Secretary Carrie Biggin

- d. Past President Chris LaRowe: SP Ice Update: Livebarn is up and running. The January My Hockey tournament has been cancelled. February's My Hockey tournament is still on schedule for now. Currently waiting on EO #11 updated info. If spectators are allowed, DCPHM regulations will apply. Regarding agenda item #6, SP Ice has waived the 500 hour volunteer requirement for this season. Will restart on 04-01-2021.

- m. Region 4 Meeting: State tournament update provided, locations have been amended to remove all Dane County locations. In lieu of no Dane County teams being able to host a site, Dane County teams are supposed to get more "wild card" slots. Possibility of stretching out playdown time period over a week to accommodate those traveling. Mask mandate will continue to be in effect. Associations are all reporting that skaters are all returning to practices at this time.

### 4. Level Rep Reports

- a. Mini-Mite: Scott reported that they had the opportunity to send a couple of teams to Beaver Dam for a few games. There will be more at the end of January.
- b. Mite: Brandon reported that teams are on a full schedule throughout mid-March. First tournament will be in two weeks.
- c. Squirt: Jennifer reported that games and tournaments are going well. Only one team rep. thus far has the ranking email needed to enter scores for seeding.
- d. PeeWee: Julie reported that coaches and team reps. are all doing excellent.

- e. WAHA Playdowns: Will begin as early as February 3<sup>rd</sup> and will conclude no later than February 11<sup>th</sup>. Schedule is expected to be released on January 25<sup>th</sup>. Teams will be seeded by rankings submitted on www.myhockeyrankings.com
- f. Grants: Madison Area Sports Commission grant was applied for from Suzanne D. There is an opportunity to earn up to \$5,000. Association will know results in a month. If anyone has any information on additional grants please pass along.
- g. Try Hockey for Free: Will be February 20<sup>th</sup> with four ice times being provided by SP-Ice. The same protocols will be followed as the last event. Information will be sent out to the communications committee.
