This e-mail will also provide reminders re: ensuring game sheets are accurate, making sure player equipment meets the current requirements and another item or two.

Coaching registration update – 170 coaches this season (177 last year). Working through any rostering issues as house coaches are added with Melissa. There is one remaining Level 1 and Level 2 coaching clinic in December. Will send reminder to coaches who may need that before 12/31.

TA Director/Secretary - Meg Swift

Held two meetings for House TAs (U14-U10 age groups) to go over expectations of the role. Melissa joined me to explain how to access team roster, labels and how to be in touch with changes. Provided all TAs with game sheets and label sheets. Shared how to update scores to Sports Engine.

Sent CBHA Team Store to all TAs to share with teams.

Rhonda Farnham conducted individual and team photos for U8-U12 teams on two Sundays (11/17 and 11/24) at Mason Motz Recreation Center in Falmouth. Shot 14 teams per day. Recreation Center worked well - Don Coulombe the building manager opened early for her so the shoot could begin at 11:30 (permit only allowed us 11-6 but he let her in at 10:15). Matt

Gilbert, Assistant Director of MMRC, reported to me that there were teams playing hockey in the hallway and this won't be allowed in the future.

Rhonda photographed all LTP and BTI players over the Sat/Sun sessions 11/9 and 11/10. Joe has requested her to come back a second weekend to get those that register for the next session as well as anyone who missed the first. U8-U12 players who missed first photo session can also come for individual, but no team available. Will be held weekend of 1/18 or 1/25.

Working on calendar. Still trying to get donations for specific days.

Operations Manager (Scheduler) - Rachel Pargeter

- Working on data entry for Co-ed travel games and uploading to website as schedules have changed. Games through the end of January have been uploaded and work on February continues.
- Practice schedules through 12/20 are all uploaded and up to date. Schedules for 12/22-1/2 have been emailed to DD's and I am waiting on them to get back to me with allocations.
- Data entry for the rest of the season is ongoing as schedules are finalized.
- Game data for December has been sent to Tom for ref scheduling and January games will be done in the next week or so..
- January rink schedules will be emailed to the rinks this week.
- December ice use will be emailed to Mike early next week.
- I have talked to TIA about the Monday night 8:30's and co-ed travel is using them in December except for holiday give-backs. Alex at TIA is totally opposed to us sub-leasing out the ice but he is okay with us giving back most of the ice in 2020, for the rest of the season. I have stressed that we don't want to lose that hour permanently as we will need it next season.
- Need to talk to Eric about MEAHA tournaments. Scott R. really doesn't want us to host all the southern conference play-ins and wants MEAHA to give us one of the state tournaments instead. I have emailed Eric about this separately.

Webmaster - Rachel Pargeter

- Girls travel games through the end of December have all been uploaded and double-checked against the NEGHL website.
- Icicle tournament is full except for U10 division.
- All Tier IV TA's now have access to score games on the MEAHA website.

Casco Bay Arena- John Veilleux

Rink is up and running. Ice has been really good. Schedule is full, and early pond hockey is proving very popular again. All new box goals made by Tom M, so feel free to grab the old ones for backyard bonfire. The barn was full and rocking for our 1st Friday night JV games on 11/29 – 14 teams and 2 on waiting list. Our Zamboni is having a new (used) conditioner (the actual ice maker) installed, and then is being dressed up with new sponsorship logos (Summit Natural Gas). We are using FIC spare for now. We are converting to NG next off season at no cost to us.

Puck retention continues to be an issue. Our supply walked out the door (including those by shooting platform) within the 1st 2 weeks. I dug into my personal supply to get us through pond hockey. We need them tagged with GPS. New ref room chairs needed – FIC folding chairs on loan.

Live Barn installed new, high def cameras – the feed is much better this season.

Review of November Action Items

- Eric:
 - Signed FIC contract
 - TIA won't allow for us to sublease our Mon 8:30pm ice time. We can give it back starting in January and Alex has promised us we will be able to have that time again next season since he appreciates that our size is growing. We have made an arrangement with him to get ice time on the Friday of the tournament weekend - 2/23
- Joe: NO UPDATE (Joe unable to attend meeting)
 - continue to monitor whether there are 2 players to be moved from CBA to Mites
- Melissa:
 - All rosters and labels for T4 teams are complete a total of 52 teams!
- Mike:
 - Continuing to try to get Nordique outstanding invoice paid. Scott recommended calling the Collisee and speaking with Jim Kane and telling him that his son Mike needs to pay this invoice. They do this regularly and the only way Scott has gotten them to pay in the past is by calling the father directly. Nordiques currently owe over \$1,500 to CBHA

 - Remind all skills and dryland instructors to complete SafeSport

 - Work with Scott and PIAS to get CBHA Store up and going for holiday pick-up store was launched (and closed 11/25) and shared with all members by CBHA email and by additional announcements from TAs

Tournaments

- Tier IV Tournaments doesn't make sense for CBHA to host all 3 T4 tournaments, need to give one back to MEAHA. Challenge is that the T4 are decided first and it always goes to all the programs without Travel. Programs with both House and Travel should get a chance to bid on both. **TO DO discuss this at MEAHA meeting**
- Leprechaun status update (Matt L.)

Schedule Upload

- Discussion about the complexity of uploading the data in response to questions about why December was posted as late as 11/29. Rachel sends draft schedule to DDs with available ice, requests confirmation. Further complicated by rinks taking back ice and offering new ice. Uploads take awhile
- **TO DO** can we put language into rink contracts next year to ensure we get this data in a more timely fashion.
- **TO DO -** nail down tournament dates sooner so alleviate challenge of ice time over these weekends.

MEAHA Report

- Tier 1 teams/committee Nordiques brought full coaching staff to MEAHA and full discussion about Tier 1 and how many teams there can be in the state based on a calculation. Haven't had a T1 team in 15 years. MEAHA suggested a subcommittee forms to discuss what this would look like and include Nordiques, Moose, CBHA and Gladiators
- Release program Matt proposed sharing a list of "naughty" players or players who
 haven't paid so it is known when they switch organizations. We will build this into our
 travel contracts in a better way next year.
- MEAHA Audit following an audit MEAHA wanted to share suggestions made to them
 with the thinking it could benefit other organizations: President's Review of bank
 transactions, post 990 on website and conduct an internal audit

- Wild petition to eliminate the possibility of players being double rostered. There is a Southern ME player who wants to be an alternate on the Wild. CBHA has kids who were rostered on the Wild. Only 2 people voted yes for double rosters
- Reporting Scores if teams don't report scores by 12 on Tues MEAHA will start fining.
 Any Safe Sport violations should be reported to Sheri
- Midget player eligibility hearing Eric reported that there was a U18 goalie for the Moose (whose team won States) who, according to multiple organizations, hadn't played in the necessary number of games to qualify for states. A Disciplinary Committee was formed and evidence gathered and ultimately MEAHA said it was OK since he played 7 out of 12 games and that rounds up to 60%

- Every coach should have an assistant coach assigned to help with goalie support to have a go-to coach/adult for that goalie
- Sat 12/7 is next Open Goalie night at CBA. Have 6 coaches and 6 shooters. Julia Johnson will be helping with this. Marc may also get Hannu (?) involved
- Plan for next September clinic to divide goalie program into age groups and run one for Mites/Squirts that Marc would lead and one for PW/Bantams that Hannu might be able to do

- Discussion about whether Pond Hockey on snow days could ever be expanded to include goalies - would be good extra ice opportunity for these players
- Marc wanting to work with Rob Cloutier, goalie coach at NYA, to create some common language and host a classroom session for all coaches early in the fall next season
