"With the beginning of the new hockey season starting, many of you have begun requesting

HCR Transfers for players that do not have a team in their primary Minor Hockey Association

(MHA). We have noticed that many of these requests have been done before the player has

registered with their primary minor hockey association. As a reminder, players are <u>**REQUIRED**</u> to first register with their primary minor hockey association. Even if you know

you will not have a team at that level, this is still the first step. If we see that they have not registered with their primary MHA first, then the HCR transfer will be denied and have the message of "The reason for the rejection is that the player has not registered with their primary minor hockey association (MHA). The player must first register with their home MHA

before an HCR transfer can be requested."
