INTRODUCTION

THE CLEVELAND SUBURBAN HOCKEY LEAGUE (CSHL) is a member in good standing of USA HOCKEY. The CSHL subscribes to all USA HOCKEY rules and regulations as presented in the USA HOCKEY Rule Book.

The North Coast High School Hockey League Division (NCHSHL) is committed to providing a positive hockey experience for high-school aged players, coaches and parents based on the principles of sportsmanship, skill development and responsibility.

NCHSHL is dedicated to providing high-school aged players the opportunity to learn, understand and develop ice hockey skills through league play. Through the programs provided, NCHSHL allows athletes to build self-esteem, self-discipline, teamwork, sportsmanship, camaraderie, ethical behavior, integrity and a respect for fellow players. The goal of this program is to promote and instill these fundamental values within each individual.

Violation of any of the Standing Rules contained herein may result in discipline to a team, an association, or any individual connected with them. Teams and individuals may be disciplined through the aforesaid system of discipline contained in the Standing Rules. Associations shall be disciplined by a majority of members of the board present at a meeting of said board.

All coaches, team managers, and program heads are required to read, learn and abide by these Standing Rules. These rules shall be enforced by the board of directors of the CSHL (the "Board"). The Board may adopt regulations to enforce these Rules.

ARTICLE I – Divisions and Levels of League Play

A. Divisions. The CSHL shall provide league play in the following divisions:

USA Hockey High School

The League will be known as the North Coast High School Hockey League (NCHSHL)

- B. <u>Season Dates</u>. The Board shall publish the league calendar no later than the meeting proceeding the regular season. The regular season will be from November to mid-February with the playoffs following the end of the regular season. Exact start and end dates will be as published in the league calendar.
- C. The League will consist of two (2) divisions: upper division (American Division) and lower division (National Division)
 - 1. Interdivisional crossover games are not required and will be considered exhibition games.
 - 2. Points for wins, losses and ties will only apply to League Games played within each respective division. Points do not apply to any interdivisional crossover games.
 - 3. Rule changes may apply to each division separately. If Rules changes are specific to a particular division, voting by division teams will be conducted separately and only affect that respective division.

ARTICLE II – CSHL – Games and Procedures

A. Definitions:

- 1. League Games are NCHSHL regular season games scheduled at the regular season scheduling meeting against other NCHSHL Teams and all playoff games. League Games are not to be played in Tournaments.
- Non-League Games are all other games scheduled at the NCHSHL regular season scheduling meetings against other NCHSHL Teams. Non-League Games do not count in the League standings.

- 3. Independent Games are all other games (including tournament games) whether against NCHSHL Teams, OHSAA Teams or OTHER teams. The Board encourages teams to schedule referees for independent games through the league assignor (contact information inside back cover).
- 4. Programs will be assessed a fee set by the Board for each League Game and Non-League Game for each season.
- 5. Any reference within these Standing Rules to NCHSHL Division Games refers to NCHSHL League Games and Non-League Games (and not to Independent Games).
- 6. A League Game that ends prematurely due to non-curfew rink problems such as electrical failure or bad ice is considered complete if at least two full periods have been played; otherwise, it shall be replayed in its entirety. Non-League games and independent games shall not be replayed
- 7. Referees in League and Non-League Games are paid by the CSHL. Referees in Independent Games are paid in cash at the game.

B. Ice Time and Curfew Games.

- 1. Minimum ice time is 100 minutes for all League Games.
- 2. There shall not be an admission fee/gate fee to any League Game.
- 3. <u>Curfew Games</u> In any League Game that is a curfew game, the home team must verbally notify the referees and the other team before the game starts: a) that it is a curfew game, and b) when the game slot ends. A team that fails to make such notification in a game that ends prematurely and that is protested in a timely manner (Article III, A-2), will have sanctions imposed against it, that may include the game being partially or entirely replayed to forfeiture, all at the home team's cost. The League requires that no anthem or player line-up announcement take place prior to a curfew game.

Note: Per USA Hockey Playing Rule 636(f) no timeouts shall be permitted during a curfew game.

Any Independent Game played against an OHSAA/Federation Team in Ohio shall follow OHSAA/Federation rules.

- C. Off Ice Officials. The home team shall provide off-ice officials for the scorer's table, a timekeeper, and a scorer. Each team must provide an off-ice official for its penalty box. All off-ice officials must be 18 years of age or older.
- D. <u>Clock Management Guidelines</u> for League Games shall be as follows:
 - 1. Set clock for a minimum five (5) minute warm-up.
 - a. Sound horn when ice is ready for warm-up.
 - b. Except as directed by a referee, start clock to run down the warm-up time when both teams enter the ice.
 - c. Sound horn when 30 seconds of warm-up time remain.
 - d. Sound horn when warm-up time is over.
 - e. Announce starting line-up for both teams (optional) Not Permitted in Curfew Games
 - f. National Anthem may be played but is optional. Not Permitted in Curfew Games
 - e. Referees should then start the game within 1 minute of end of Announcements and/or Anthem.
 - 2. Set clock for:
 - a. Three Fifteen (15) minute periods for the High School Division.
 - b. The first two periods will be standard stop-time. If the game is a curfew game, with proper notification under B-3, the third period shall be stop-time UNTIL purchased time for the game and the game clock time remaining are equal. At that time, the time keeper shall inform both benches and the referees that the clock will go to running time to assure that the game is completed within the required purchased ice time. If proper notification under B-3 was not made, the home team may not change from stop-time to running time. The game shall remain in stop-time until the rink ends the game, at which time the scorer should note the time remaining in

the game on the scoresheet. The home team should be prepared to partially or entirely replay the game or forfeit the game if it is properly protested, as noted above (Article II, B-3).

- c. Any time in the game that there is a six (6) goal differential, the game will be played in running time, unless the goal differential becomes less than six (6) goals. At that time the game shall return to stop-time. If there is a ten (10) goal differential at the end of the second period or any time during the third period, the game will end at that point. The visiting team shall leave the ice and the home team may stay and use its ice time for practice.
- d. <u>In running time, there will be no timeouts and no stoppage for goals, injuries, etc.</u> The clock may be stopped only upon the instructions of a referee or if penalty times cannot be recorded without stopping the clock.
- e. Minor penalties in running time shall be 2 minutes, with no change in major or misconduct penalty time.
- f. Penalties for players already in the penalty box when running time begins shall not be adjusted.
- g. In Curfew Games, the scorekeeper shall stop the clock to set a penalty and start the when play resumes (puck drop).

E. Overtime.

- 1. If a League Game is tied at the end of Regulation Time, one five (5) minute, three (3) on three (3), sudden death overtime shall be played. Teams shall switch ends at the end of the third period.
- 2. If still tied at the end of the overtime, a shootout shall take place as noted in Playoff Game Rules/Annex D **Tie** Games.
- 3. Any Overtime period shall be considered part of the game and all unexpired penalties shall remain in force in accordance with NHL Rule 84.3. Additionally, any timeout that is not used during regulation time will not be allowed to be used in overtime. NHL Rule 84.3 and reference tables are found in Annex F. No additional timeouts are added for an overtime period.

F. Ice Cuts.

An ice cut should be made a minimum of once per Game, except with approval of both coaches and referees. This should be noted on the scoresheet and no further action shall be taken to hear complaints or replay the game.

G. Team Representative/Manager.

It is strongly recommended that a Team Representative/Manager be appointed for each team. This representative/manager should attend all League Games and be prepared to report to his Head of Program on any incidents involving a coach, player, manager, official or fan.

H. Scores and Score sheets.

- 1. The home team is responsible for providing the official NCHSHL score sheet before each game and for providing scorekeepers to correctly fill out the score sheet. The scorekeepers must put the game number and date on the score sheet before the game and ensure that referees and Head Coaches sign the score sheet. Scorekeepers must also verify that the name the Head Coach present is written or printed legibly on all copies of the score sheet. Head Coach should ensure that only players present on the bench at the game are listed. If a player listed on a preprinted form is not at that game, his name shall be crossed out. Additionally, if a player or coach is serving a game suspension, the name shall be crossed out and it must be noted on the score sheet that the individual is serving the suspension.
- 2. A scanned version of the original white score sheet and the Scores of League Games shall be uploaded into the League website after the game by the HOME team. This shall be done within 48 hours of the game by the HOME team. Exceptions to the above procedures are forfeited games (see Article III-B-3)

The original copy of any score sheet should be kept by the HOME team representative/manager. Any score sheet not uploaded into the League website within 48 hours may cause the responsible program to be fined up to \$100.

Score sheets may not be used to lodge any protests or complaints by coaches or managers; the only
persons to use the back of the original white score sheet will be the referees in order to record any penalties
or descriptions of their official duties during a game. League Officials are to notify coaches if a player or

coach is to miss a game or games due to a penalty assessment. A League Official's failure to make such notification shall not excuse a coach from enforcing all game suspensions.

- 4. Complaints regarding officiating shall be forwarded in writing to the League (NCHSHL Committee Chairman) with a copy to the CSHL Secretary and must be signed by the Head of Program making the complaint.

 Unsigned complaints will be discarded. The name(s) of the person(s) initiating the complaint must be included.
- 5. All League Games must be officiated by USA Hockey registered and approved referees, assigned by the League. There shall be two referees scheduled for each game. A Game will be considered official if officiated by only one referee and both teams agree to play the game. If no referee shows up at a League Game, the game may not be played and must be rescheduled. Teams are not permitted to use the ice time to play a "controlled scrimmage" without referees.
- 6. All League Games will use current USA Hockey Rules.

I. Protective Gear and Socks.

- All players on a team shall wear the same color helmets, pants, jerseys and socks on each leg.
 Goalkeepers must follow this guideline except for helmets and socks. No stickers other than Team or
 League stickers are allowed on any helmets. Pants must be of matching length.
- 2. For the first violation of Rule II-I-1, the violating player shall be ruled off the ice and the coach shall be notified that for the next violation of this rule by any player on the team a 10-minute misconduct penalty shall be imposed.
- 3. Any deviation to Article II, I-1 above requires the approval of the League prior to the start of the game.

J. Jersey Colors

Home Team shall wear White (or Light) Jerseys. The Visiting Team shall wear Dark Jerseys. Where a conflict in jersey colors exists, it is the responsibility of the home team to make the necessary changes.

K. <u>Home Ice Sheets</u>. At least 10 days prior to the regular season scheduling meeting each team shall provide the Board an adequate number of ice sheets to play its home games

ARTICLE III – Protests, Forfeits, CSHL Game Changes and Cancellations

A. Protests.

- 1. Protests may be lodged only in conjunction with incidents/events that occur during the playing of a League Game. Only the violation of League rules as stated in these Standing Rules may be protested. Referee judgment calls shall not be subject to protest.
- 2. All protests shall be submitted by the protesting Head of Program and distributed via e-mail to the CSHL Secretary with a copy to the NCHSHL Committee Chairman, and to the opposing team Head of Program within 72 hours of the incident/event. This deadline may not be waived. The formal protest shall include the teams involved, game number, date and the specific rule that is alleged to have been violated with specific information about the incident/event.
- 3. The CSHL Disciplinary/Review Committee will review the protest to determine if it meets the criteria of a League Protest.
- 4. The League will assess each member program a "deposit" of \$100 that is included in League Fees. This money will be pledged for any protest submitted by the association's head of program during the year. If a petition is turned down a \$100 protest fee will be charged to the association and the program will be invoiced to replace the "deposit". No further protest may be submitted until the new deposit is received. The program deposit will carry forward from year to year if unused or until the rule is amended.

5. The CSHL Disciplinary/Review Committee will notify the involved parties of the time and place of the hearing. A hearing may be deferred until the end of the season. No more than 4 persons per program will be permitted at the hearing. One of those present must be the Head of Program of the protesting program.

B. Forfeits.

- 1. Any team that fails to show for a League Game will receive a forfeit and be subject to additional costs and disciplinary action, as hereinafter provided.
- 2. In the event of a forfeit of a League or Non-League Game, a fine of \$100, league fees and referee costs for both teams shall be levied against the forfeiting team. The non-forfeiting team shall not be assessed league fees or referee costs.
- 3. Forfeited League Games shall be recorded as a 1-0 win for the team being forfeited against, and this score should be uploaded into the League website immediately after the forfeit has been determined by the team benefitting from the forfeit. A copy of the score sheet must be scanned and uploaded into the League website AND e-mailed to the NCHSHL Committee Chairman by the benefitting team.
- 4. Forfeits of League Games may result in a hearing before the Board and the possible suspension of team management. If the Board determines, in its discretion, that the forfeit was deliberate or avoidable by virtue of procedures outlined in these Standing Rules, the forfeiting team will be ineligible for the playoffs.

C. Rescheduled Games.

- 10 Day Grace Period (2 coaches must agree). Upon the agreement of both coaches, regular season NCHSHL Games may be rescheduled without charge in the first 10 calendar days after the regular season scheduling meeting.
- 2. No NCHSHL Game may be rescheduled on or after December 1st. Any request for a waiver of this rule may be submitted only by the Head of Program of the requesting team to the NCHSHL Committee Chairman. The request for a waiver must be in writing. The League will only accept requests for waivers that include the agreement of the Heads of Programs of both teams.
- 3. <u>5 Day Rule</u>. The game reschedule form for any League Game rescheduled under this rule must be submitted at least 5 days before the originally scheduled game date in order to give the League time to reschedule referees.
- 4. Any rescheduled game must be played before/on the date determined as the end of regular season.
- 5. The program that initiates any rescheduling, that is approved, will be assessed \$100 plus all costs.

D. Game Cancellations.

- 1. League Games. No League Game may be cancelled.
- 2. Non-League Games. The NCHSHL will accept game cancellations of non-League games from the Head of Program of the team canceling the game ONLY after both Heads of Program have agreed to cancel such game. An attempt at cancellation by any other party will be disregarded and will subject the team to disciplinary action. The cancellation must be emailed to the Referee Assigner and NCHSHL Committee Chairman. The program that initiates any cancellation will be assessed \$100 plus all costs.

E. Weather Conditions/Clerical Error.

- 1. Any League Game cancelled due to any weather or ice conditions or clerical error by the League must be rescheduled within 10 days for play at a later date. There will be no fee levied for a League Game cancelled under this rule if it is rescheduled within 10 days.
- 2. Deliberate refusal to reschedule will result in disciplinary action by the Board, including the assessment of all costs involved to the refusing team.

Note: please notify the NCHSHL Committee Chairman and the Referee Assigner (phone numbers on a league contact list) as soon as it is determined to cancel a game due to weather.

F. Substitution of Games.

Once a League Game is scheduled, no team may substitute for the originally scheduled teams without the permission of the Referee Assignor.

- G. Policy for Rescheduled Games due to Illness/Medical or any reason not noted within the NCHSHL Rules.
- 1) If a team has a minimum of 11 players, ready and able to play No reschedule and original game to be played.
- 2) If a team has a JV (for Varsity) or a Varsity (for JV) and can bring up players or play down players (not including 10 player lock list from Varsity), to reach a minimum of 11 players No reschedule and original game to be played.
- 3) If a Head Coach is unavailable due to illness or any other reason, and at least 1 team coach (on that team USA Hockey roster) can be present for the game No reschedule and the original game to be played.
- 4) If rescheduling is unavoidable, the game must be completed prior to the end of the season, including using a different rink location and scheduling on a week-night date if needed. A new game date must be scheduled within 10 days of the original game date. Both coaches or HOP must agree to the rescheduled date and/or location.
- 5) Team that requests rescheduling is required to pay all costs, including ice cost, referees, and \$100 League rescheduling fee.
- 6) If the game is not completed prior to the end of the season, the team requesting the reschedule from the original date will forfeit the game and the opposing team will receive a 1-0 win.

ARTICLE IV – Teams, Players and Coaches

A. Rosters and Eligibility

- 1. At least 5 days before the regular season begins, all NCHSHL Teams must submit to the NCHSHL Committee Chairman a copy of its Team Roster Registration Form approved by the USA Hockey District Registrar and a NCHSHL TEAM ROSTER in an excel spreadsheet format. Such NCHSHL TEAM ROSTER shall include player's name and jersey numbers (home and away), grade level (9,10,11,12), Current Year High School, Previous Year Team, and Release Status. Such ROSTER may be posted on the League website. Any amendment to this form must be submitted with reasons for the change to the NCHSHL Committee Chairman for approval before any players added may play in a League Game.
- 2. Only players listed on the Official NCHSHL Team Roster may play in League Games. If a team violates this Rule by playing a player not listed on the team's Official NCHSHL Team Roster in a League Game, it shall forfeit that game and shall be ineligible for the playoffs. The coach may be penalized further by the Disciplinary Committee.
- A player on an Official NCHSHL Team Roster may not play for any other registered team during the regular season without League/Board approval and the written permission of the NCHSHL Committee Chairman. A NCHSHL player who wishes to play for another registered team or during the regular season must send an email request through the team's Head of Program to the NCHSHL Committee Chairman detailing the name of the other team, head coach's contact information, how many games the player expects to play for the other team and the reason for the dual rostering. The NCHSHL Committee Chairman shall promptly respond with a decision. If a NCHSHL player plays for a non-NCHSHL team during the regular season without obtaining such permission from the NCHSHL Committee Chairman, then any subsequent NCHSHL games in which he plays shall be forfeited by his team.
- 4. Player eligibility shall follow the current year USA Hockey Annual Guide/Classifications, as it relates to enrollment as a High School eligible player.
- 5. **USA Hockey Roster links** will be posted on the League website. Any player not posted on the "official roster" on the League website as of December 31st is deemed ineligible for Buckeye Cup participation.

B. Team Rules.

A NCHSHL Team is one that participates in the NCHSHL regular season. All NCHSHL Teams must register a minimum of ten (10) team members by the start of the regular season, and must have a minimum of six (6)

players in uniform for all League Games. A maximum of thirty (30) players may be on one team roster, with no more than 20 players dressed for any game. (as noted in the current USA Hockey Annual Guide, Team Membership and Registration)

Each Program/Team is required to secure USA Hockey Insurance and any additional insurance required to allow play with any OHSAA/Federation team as directed by the League.

A team interested in joining the NCHSHL League must play against at least five League teams prior to petitioning to join the League. Requests to be accepted into the League for the next season will be heard at the first League meeting following the end of the League season (including playoffs). No teams may join the League in mid-season.

A team previously a League member may petition to rejoin the League within 2 years after the completion of the league season in which that program competed in the league. Proposed New Members or Previous League Members will require a 2/3 majority of current League members for approval.

League members may also vote to allow a probationary or exhibition season (1 year) for a new team. After the first season, a second vote is required to be accepted as a voting member of the league.

C. Obligations When a Player Changes Programs.

- 1. Before a player may move from one NCHSHL or CSHL Member or Associate Program ("Program") to another, he shall submit a written request to be released from the member program that he is currently registered. He must complete his financial obligations and return program equipment or program records to his former Program. He must present evidence of this to the new Program in the form of a written "Release" issued by the Head of the former Program. A "Move" occurs upon the earlier occurrence of:
 - a. the player being added to a team roster or
 - b. the player playing in any game with the new Program.

If all obligations have been met, a release shall not be unreasonably withheld or delayed.

- 2. The new Program shall be fined \$100 per player per game played, if a player:
 - a. Moves, and
 - b. Owes money to the former Program, and
 - c. Does NOT present a Release to the new Program, and
 - d. Plays any games with the new Program,

In addition, if the game is a NCHSHL League Game, it may be forfeited.

- 3. The CSHL Review Committee will resolve all disputes and will monitor compliance with this Rule. The only sanction allowed to be imposed on a player is a prohibition on playing for a Program until all obligations are satisfied. A decision of the CSHL Review Committee is only determinative of the parties' participation in the CSHL or NCHSHL; it is not a decision on the legal obligations of the parties or the merits of their case.
- 4. All member programs have sole responsibility for collecting any agreed upon fees/dues from their member players and are encouraged to obtain signed and dated contracts to clearly show the obligations incurred by a player. Absence of a signed contract is not fatal, but will be taken into account in making a decision.
- 6. After the first day of the regular season any movement of a player from one NCHSHL/CSHL program to another not only must receive written permission/release from the head of program of his original team, but the move must be submitted by the head of program of the team receiving the player to the CSHL Secretary and NCHSHL Committee Chairman for review. The NCHSHL/CSHL may deny or impose conditions upon movement. Until a decision is rendered, the player is ineligible from competing with his new team. Upon approval, the NCHSHL/CSHL will notify the teams.

- 7. Players moving from one member program to another member program after the first day of regular season, will have playoff eligibility based on the total number of League games of the receiving team, whether already played or still to be played at the time of transfer.
- 8. Any player from a non-Member program (i.e. player moving into the jurisdiction of NCHSHL/CSHL teams) joining a team of a Member program requires the head of program of the team receiving the player to notify the CSHL Secretary and NCHSHL Committee Chairman for a review. The NCHSHL/CSHL may deny or impose conditions upon movement. Until a decision is rendered, the player is ineligible from competing with his new team. Upon approval, the NCHSHL/CSHL will notify the teams.

D. Intra-league Player Movement

- 1. Any player who was on a USA Hockey Roster (the "Roster") of a NCHSHL team anytime during the previous season but did not meet playoff eligibility requirements for the program's Varsity level team for the previous season (being present on the bench and noted on the game scoresheet for at least 50% of his/her team's League games) is free to transfer to a new NCHSHL team for the current season subject to the following conditions:
 - a. The player must satisfy all financial obligations to his previous team.
 - b. The player must be on the new team's Roster before the first day of the regular season.
 - c. Only one player from team A may transfer to team B per year. This applies only to players that did meet eligibility requirements for the previous season.
 - d. The player must sit out **25% of the total** regular season games for his new team. This must be clearly marked on the game scoresheet involving the "sit out" rule. This applies only to players that did meet eligibility requirements for the previous season.
 - e. If a program's second team player(s) is/are entering their junior or senior year in school, the one player per team rule and 25% of the total sit-out rule (Article IV, D-1, c & d) will not apply.

Note: The purpose of this rule is to provide some flexibility for player movement while balancing the interests of players who wish to change programs with the interests of teams in avoiding disruption caused by too many players leaving at once.

2. If Rule Article IV, D-1.c causes hardship for two or more players, the HOP may apply to the NCHSHL review committee for a waiver. The application must be submitted in writing prior to November 1 and include all pertinent information. The parents or HOP must prove that there is a substantial hardship on both players that can be relieved by a waiver and that moving to two (or more) separate teams is impractical. The review committee can grant or deny the application solely on the submission of this application or may convene a hearing to consider oral testimony. The decisions of the review committee are final and not subject to appeal.

E. Anti-Recruiting Policy.

- 1. The League discourages "recruiting" of players from other teams in the League. A player who played at the High School age level in the previous year and wants to play for a different team must follow the player movement procedures and obtain a release from the previous program as noted above.
- 2. Any ineligible player who plays in any NCHSHL League Game will cause the offending team to forfeit that game.
- Any coach that is accused of recruiting and where proof of such recruiting practices is presented to the League may be required to attend a hearing of the Discipline Committee to determine if any further action is required.

F. Head Coaches/Assistant Coaches.

1. Head coaches and Assistant coaches of NCHSHL Teams must complete the appropriate level of coach's training as required by USA Hockey.

- 2. Requirements:
 - a. All Coaches must be registered with USAH before the regular season begins
 - b. All Coaches must complete the required USAH coaching education (CEP) Certification Level
 - c. All Coaches must complete the age-appropriate module
 - d. All coaches must complete background check requirements of USA Hockey
 - e. All coaches must complete concussion training as required by the state of Ohio.
 - f. All coaches must complete Safe Sports training as required
 - g. All coaches must wear an HECC approved helmet with a current date sticker on the ice. All ice hockey coaches must properly wear an approved ice hockey helmet during all ice sessions. Failure to comply will result in a 30-day suspension from all activities involving USA Hockey registered programs. (USA Hockey Annual Guide Rules & Regulations, Section V.A (pg. 160 2022-23 Guide).
- 3. Only Coaches will be allowed on the ice for practice and on the bench for games.

ARTICLE V – Game Rules, Suspension and Conduct

- A. The CSHL/NCHSHL adheres strictly to the playing rules of USA Hockey. This allows the CSHL/NCHSHL to impose Supplementary Discipline as noted in Rule 410. Teams that Play OHSAA/Federation Teams will adhere to the playing rules of OHSAA/Federation for those Games. It is the responsibility of the coaches to make sure that these rules are fully understood. All members must also comply with USA Hockey requirements with respect to Progressive Suspensions as noted in USA Hockey Rule 411 and Game Misconducts as noted in Rules 401(b), 403(b), 404(a) and (b) (as noted in current USA Hockey Official Rules 2021-2025)
 - 1. For purposes of this rule, a season starts **September 1** and ends **March 31**. **Players**, Programs and coaches have an affirmative duty to keep track of all of its player's Game Misconducts **and Suspensions** and inform the NCHSHL Committee Chairman and CSHL Secretary immediately when these rules apply.
 - Note: Because of the definition of a season, any game misconduct penalty received in any league game, any tournament game or any other **USA Hockey** game while playing for team on or after **September 1 and through March 31** will count towards the total number of game misconduct penalties.
 - 2. Rule 411 (Casebook Situation 1): A player is rostered and plays on two different USA Hockey sanctioned teams, one 18 & under and one high school team. During the course of a season, the player receives a major plus game misconduct for an aggressive infraction while playing on the high school team but had previously received two aggressive infraction major penalties while playing with the 18 & under team. Since penalties were assessed while playing for different teams, does the progressive suspension rule apply and how is the suspension served?

Yes, the intent of the rule is to hold the individual player accountable for their actions and the progressive major penalties accumulate while playing in any USA Hockey sanctioned game during the course of a season (Rule reference 411(a).

The player and/or team manager(s) are responsible for being aware of the rule and serving the appropriate game suspension(s) whether or not they have been officially notified by the proper disciplinary authority.

In this instance, the player would be suspended for the next game that appears of the schedule of that team (to serve the game misconduct one-game suspension) in addition to the next three regularly scheduled USA Hockey sanctioned games they would have participated in – regardless as to which team has game(s) scheduled. The onus is on the player to provide the necessary documentation and proof of suspension served to the proper disciplinary authority.

B. Fan Abuse.

- 1. The League will provide security for Playoff Games.
- 2. If an official determines during a NCHSHL Game that any fan is continually abusive to a player, an official, or to other fans, that fan may be ejected. The officials are responsible for the enforcement of this rule when

informed by minor officials. If that particular fan refuses to leave, the official will instruct Security to remove the fan from the arena.

- 2. If an official determines during a NCHSHL Game that fan abuse is excessive, he has the authority to remove both teams from the ice (excepting minor officials) until all of the spectators clear the arena at the direction of Security. If the fans refuse to leave, the game is terminated and the matter will be referred to the Board.
- 3. It is the responsibility of the home team to protect all officials from irate and/or abusive fans, and to assure their safety out of the rink. Neglect to do so will result in censure or suspension by the Board.

C. Use of Noisemakers at games:

Those that are not permitted: Whistles (interfere with officials' whistles), air horns, or any other extremely disruptive noisemakers at the discretion of the on-ice officials.

- D. <u>The customary handshake</u> between teams will take place after the game. The visiting team or the team closest to the exit will leave the ice surface first as directed by the on-ice officials.
 - 1. At the conclusion of the game, both teams will return to their respective benches and wait for the referees' signal to return to the ice for the handshake. At the discretion of the referee, where he senses a potential problem following a game, he may not signal for the handshake. The Board will deal with any team starting trouble or fighting during the handshake immediately upon notification.
 - 2. If a referee determines that a coach contributed in any fashion to a player receiving a Game Misconduct penalty during or after the handshake that coach may also be assessed a Game Misconduct penalty.

E. Game Ejection.

A referee may eject any player, coach or manager from any game for any reason. This game ejection <u>IS NOT a Game Misconduct</u> and does not carry a game suspension. The score sheet must indicate this by using the phrase "game ejection" in the penalty area of the score sheet. Upon ejection, the individual shall leave the rink (i.e. playing surface, bench, spectator area, etc.). Failure to abide to this may result in a harsher penalty.

F. Official's Rating System.

Officials are required to conduct themselves in a business-like, sportsman-like and non-vindictive manner at all times. The actions of an Official must be above reproach. Actions such as "baiting" or inciting players or coaches is strictly prohibited.

The Board may from year to year adopt an Official's rating system to reward good Officials with recognition. On-lce Officials are ambassadors of the game and shall always conduct themselves with this responsibility in mind

ARTICLE VI – Playoffs and Buckeye Cup

- A. <u>Banners</u> will be awarded to all Regular Season Division winners (2) and the Playoff Champions (2). If teams are tied in points for first place of the regular season, the procedures described in Annex E will be used to determine the Division champion. Teams will be seeded based on points earned during the Regular Season. Points for Regular Season are based on Three (3) points for a Regulation time win, Two (2) points for an OT/Shootout win, One (1) point for an OT/Shootout loss and Zero (0) points for a Regulation time loss
- B. Individual awards may be presented as determined by the League for:
 - 1. Most Valuable Forward
 - 2. Most Valuable Defenseman
 - 3. Most Valuable Goaltender

C. NCHSHL Division Playoffs.

- Teams will be seeded based on points earned during the Regular Season. Points for the Regular Season are based on Three (3) points for a Regulation time win, Two (2) points for an OT/Shootout win, One (1) point for an OT/Shootout loss and Zero (0) points for a Regulation time loss. If teams are tied in points for the regular season, the most current USA Hockey Tie-Breaker Procedure (Annex E) will be used to determine Playoff seeding.
- 2. Playoff Overtime / Shootout Procedures shall follow the most current USA Hockey Guidebook format as noted in Annex D.
- 3. The following teams will not be eligible for the NCHSHL playoffs or the Regular Season Champion Banner:
 - a. A team guilty of deliberately forfeiting a NCHSHL Game, as determined by the Board.
 - b. A team that played a non-rostered player in violation of Rule IV-A.
 - c. A team from a program whose League Fees have not been paid.

D. Player Eligibility for NCHSHL Playoffs and Buckeye Cup

A player is **eligible** to participate in his team's NCHSHL playoff games **if the player was able to play**, present on the bench and noted on the scoresheet for at least 50% of his team's League Games. Within 3 days of the end of the regular season each playoff team shall submit to the NCHSHL Committee Chairman a certification by the coach indicating which players on that team's Official NCHSHL Team Roster meet this 50% rule and which do not. Such form will include a statement by the coach that he will not dress in any playoff game any player that does not meet this 50% rule. A player who does not meet this rule because of injury may request a waiver from the Board.

All Buckeye Cup eligibility requirements are described in the latest revision of the Buckeye Cup Rules set up by the Buckeye Cup representatives from participating cities. These requirements will be made available to the League contacts upon completion.

E. NCHSHL Playoff Games.

- 1. The Board shall determine the time and place of all playoff games.
- 2. The higher seeded team shall be the home team, and shall wear its light-colored jerseys.
- All playoff games shall be played within a 60-mile radius of downtown Cleveland. No playoff game may start before 8:00am.
- 4. The playoffs shall use seeding as follows 2 divisions of 4 teams. Divisions will be noted as American and National. Each Division will have a Playoff Champion. If the division has more than 4 teams, playing game(s) will determine the Four (4) teams advancing to the playoffs as noted below:
 - a. The 1st and 2nd place teams in regular season will have a bye for the Play-in Round.
 - b. The 7th and lower place teams in regular season will not be eligible for the playoffs
 - c. Play-in games will be #3 vs #6 and #4 vs #5 based on regular season placement.
 - d. Semi Final Round will be #1 vs winner of #4/#5 and #2 vs winner of #3/#6
- 5. Winners of the Semi Final Round games will play the Championship Game for each division.
- 6. Play-in Games shall be played on Thursday and/or Friday, Semi-Final Games played on Saturday and Championship Games played on Sunday per the League calendar.

F. Buckeye Cup Qualifications - Refer to current Buckeye Cup Rules for Clarification

- 1. Automatic berth (1) to the NCHSHL Buckeye Cup will be the NCHSHL Upper Division (American) Playoff Champion. If the Playoff Champion is ineligible to participate in the Buckeye Cup, the following order shall be used to determine the automatic berth:
 - a. Playoff Runner-up
 - b. Regular Season Upper Division (American) Champion
 - c. Next Eligible Upper Division (American) team ranked by points. If teams are tied using this format, the USA Hockey tie-breaker formulas shall be used to determine the team receiving the automatic berth. This format is also shown in the Buckeye Cup Rules, Section 21.
- 2. Any remaining at-large seeds will be determined by Buckeye Cup Rules.

G. Buckeye Cup Team Fees

- 1. A qualifying Team must be prepared to pay the Buckeye Cup Fee immediately to the Buckeye Cup hosting league.
- 2. Fees must be paid upon determination that the team earned one of the automatic bids.
- 3. Failure to pay the Buckeye Cup fee upon qualifying results in denial of participation in the Buckeye Cup

Article VII - Jurisdiction, Best Interest of the League and Conduct Unbecoming a Member.

A. Jurisdiction.

By participating in the CSHL-NCHSHL, member Programs, teams, players, coaches and parents submit to the jurisdiction of the Board over all matters pertaining to the League, games and disciplinary matters regardless of actions taken or determinations made by any other body (e.g. USA Hockey, OHSAA, etc).

B. <u>Best Interest of the League.</u>

Notwithstanding any other provision contained in these Standing Rules, the Board may take any action or make any determination it deems necessary in the best interest of the League, provided that if the Board takes any action or makes any determination based on this Article, it shall set forth its reasons therefore in writing and promptly distribute such to the heads of programs.

C. Conduct Unbecoming a Member.

Any member Program, team, player, coach or parent who engages in conduct unbecoming a member of the CSHL/NCHSHL or detrimental to the League as determined by the Board, in its sole discretion, shall be punished as the Board may direct.

D. Responsibility.

- 1. Each program head is responsible for compliance with these Rules and decisions of the Board by all teams, coaches, parents and players in his program.
- 2. The CSHL/NCHSHL conducts mandatory meetings for the Head of Programs throughout the season. A \$100.00 penalty shall be imposed for each missed meeting to programs that are not represented at these meetings unless of an excused absence as approved by the CSHL Board Proxy representation shall be accepted upon prior notice to the NCHSHL Committee Chairman or CSHL Secretary.

Article VIII - Miscellaneous.

A. Amendment.

All proposed amendments to these Standing Rules must be submitted in writing to the Board for review, and shall then be placed before the membership for discussion and balloting. All proposed amendments shall be distributed to the membership at least 30 days before the meeting at which such amendments are to be voted on. Amendments may be passed by a majority vote of the voting members present at the Annual Meeting or by a 2/3rds vote of the voting members present at any other meeting of the membership.

B. Waiver.

The Board may, upon receipt of a written request, waive any Standing Rule for good cause. The Board must issue its waiver in writing setting forth its reasons therefore. If the request is granted in whole or in part, the Board shall promptly distribute the request for waiver and the Board's decision regarding the request to the heads of programs

C. Self-Reporting of Violations.

Each member Program (including all individual members thereof) is required to promptly inform the NCHSHL Committee Chairman whenever it discovers that a player, coach, manager or team belonging to that Program violated any of these Standing Rules. If the Board discovers in the course of an investigation of a potential rules violation that a member Program knew about a violation but did not report it, the disciplinary consequences will be higher.

D. Referee Conflict of Interest.

No referee shall officiate in a game in which his father, mother, sister, brother, son, daughter, husband or wife is a coach, manager or player on one of the participating teams. Additionally, NO current coach or manager of a NCHSHL member team, who is also an USA Hockey referee, may officiate any NCHSHL League Game. If a scheduling mistake is made and this occurs, the referee must notify both coach of this relationship and obtain agreement from both coaches in writing on the score sheet to play the game prior to the start of the game. Failure to obtain such agreement will cause such game to be cancelled and replayed.

E. Use of Gender.

Within these Standing Rules, the words "he," "him" and "his" are used to include both male and female participants.

F. Disciplinary Review Committee

The Board shall annually create a CSHL Disciplinary/Review Committee. The Committee, through its Chair, is directly responsible to the Board in performing its functions

- 1. <u>Organization of the Committee</u> The Committee shall consist of an appointed member of the Board as the Chair of the Committee and at least two (2) other members of the Board.
- Committee Meeting Dates This standing Committee convenes as necessary to review and act upon rules violation or other incidents brought to the attention of the Board. Committee actions will be initiated by:
 - a. Notice to the CSHL by a Mid-Am District representative informing them of a referee report of a match penalty infraction of USA Hockey rules
 - b. A request from the CSHL Board for violations of the Standing Rules.

The Committee will respond/act on any such notification, as soon as all pertinent materials and persons involved in the issue at hand can be assembled, but no later than 30 days after such notification.

3. Committee Actions/Decisions -

Committee actions will be based on the current issue of USA Hockey Official Rules, Mid-Am District hockey rules and regulations, NCHSHL or CSHL Standing Rules, and generally accepted policies for implementation of all such rules and regulations. Committee decisions are to be based on a simple majority vote. In situations where a tie vote is possible, a vote by the chair will be reserved and occur only as a tiebreaker. The chair may note conflict of interest or appearance of conflict of interest and excuse him/herself or request another member of the committee to excuse him/herself from the proceedings in which the conflict or appearance of conflict is thought to occur. The Chair as necessary to compensate for abstaining or absent members and conflict of interest exclusions pro tempore will appoint members. The Co-Chair will serve as Chair should the appointed chair be absent, or in a conflict situation.

- 4. <u>Hearing Notice</u> A hearing notice shall be issued on matters involving disciplinary or other similar action. This notice is to provide the Disciplinary/Review Committee and the involved parties full information on the nature of the hearing. This hearing notice shall be distributed no less than three (3) days prior to the hearing. In order to ensure a fair procedure, the notice is to include:
 - a. The date, time and place of the hearing.
 - b. Summary of violation(s) with sufficient detail to enable the individual against whom the action is being considered to answer to the charges.
 - c. The right of the individual to be accompanied at the hearing by their representatives (parents, head coach, Head of Program, etc).
- 5. <u>Hearing Procedures</u> Any hearing involving a disciplinary or other similar action of a confidential or quasi-confidential or personal nature shall be conducted in closed session with those present being members of the Committee and:
 - a. The person against whom an action is being considered.
 - b. If the person against whom an action is being considered is a minor, his/her parent(s) or designated guardian shall accompany them.
 - c. Head of Program of the individual against whom an action is directed.
 - d. Head Coach of the team if the individual against whom an action is being considered is a player.
 - e. Any aggrieved person, including parents or designated guardians and/or coach for players, team or program involved.

Individuals providing testimony in such proceeding shall appear in the proceeding singly, and be excused after providing testimony.

The deliberations of the Committee in session will be duly recorded. The decision of the Committee is to be 48 hours upon the conclusion of the hearing and at which time the parties to the action shall be apprised of the committee's decisions.

Penalties imposed by the Committee may affirm or overturn the original penalty imposed by a game official. It shall be understood that the CSHL/NCHSHL has the right to impose supplemental discipline under Rule 410 of the current USA Hockey Official Rules.

Any game scheduled after the scheduling meeting will be cash at the game. Don Lewis will e-mail back confirmation that referees have been scheduled and confirm the referee fee for that game (NCHSHL fees for 2020-2021 are \$80.00 per official per game). A two-day notice is greatly appreciated.

B. To Request a game change (this is a game with a game number already)

Requesting coach (before grace period ends) or Requesting Head of Program (after grace period ends) or opposing Head of Program (after grace period ends) notifying him/her of the game change particulars (i.e., new date/time/rink). The opposing coach or Head of program must forward that request to cshlgamechange@gmail.com with their approval of the game change. Once the forwarded e-mail is received by Don Lewis, the change will be made in the Arbiter referee assigning website and also on the CSHL website. When the requested changes have been made in both websites, Don Lewis will send a reply to all (and copy the League for the processing of game change fees) stating that the changes have been made. The e-mail from the requesting coach or Head of Program must follow this protocol or it will be returned and no changes will be made until a corrected e-mail is received.

ANNEX D - TIE GAMES

A. Overtime -

Preliminary Round Games.

All Games Played to a Winner

If the game is tied following regulation play, <u>one five (5) minute sudden-death overtime period</u> shall be played. At the completion of the third period, the tied teams shall receive a two (2) minute rest period. The teams will remain on the ice. The teams shall change ends. <u>If the score is tied at the end of the five (5) minute sudden-death overtime period, there shall be a shootout</u>. The winner of the shootout will be credited with one additional goal in the final score.

SEMI-FINAL AND CHAMPIONSHIP TIE GAME

All Games Played to a Winner

If the game is tied following regulation play, one (1) sudden-death overtime period shall be played. At the completion of the third period, the tied teams shall receive a two (2) minute rest period. The length of the overtime shall be equal to the length of the third period and shall be sudden death. Teams shall switch ends at the end of the third period. Overtime shall be played 5 on 5 (five skaters plus a goalkeeper). If the score is tied at the end of the sudden-death overtime period, there shall be a shootout.

B. Shootout Procedures

The shootout will be conducted as follows:

- A shootout is defined as a player attempting to score a goal and the opposing goalkeeper attempting to stop the shooter from scoring the goal.
- The home team shall have the choice whether his/her team will shoot first or second.
- All goalkeepers and all players from both teams listed on the official game sheet shall be eligible to participate in the shootout.
- The goalkeepers will defend the net they were defending in the 3rd period.
- Any penalized player whose penalty had not been completed when the overtime period ended or who receives a penalty during a shootout procedure is not eligible to participate in any portion of the shootout procedure(s) and must remain in the penalty box.
- The shootout procedure shall begin with five different individual shooters from each team taking alternate shots. The players do not need to be named beforehand.
- The goalkeepers from each team may be changed after each shot.
- The players of both teams will take the shots alternately until a decisive goal is scored. The remaining shots will not be taken.
- If after the shootout, the shootout score is still tied, there will be a sudden death shootout.

C. Sudden Death Shootout Procedures

The sudden death shootout will be conducted as follows:

- A sudden death shootout is defined as each team attempting a shot. Should one team be successful and the other team not, the successful team shall win the shootout.
- Teams will select their shooters to participate in any order in the sudden death shootout, whether or not they shot in the previous round. The last player in the first round of the shootout may be the first player in the sudden death shootout.
- Players in a sudden death shootout shall not be allowed to take another shot until four additional shooters have completed their attempts.
- All goalkeepers and all players from both teams listed on the official game sheet shall be eligible to participate in the shootout.

- Any penalized player whose penalty had not been completed when the overtime period ended or who receives a penalty during a shootout procedure is not eligible to participate in any portion of the shootout procedure(s) and must remain in the penalty box.
- The goalkeepers from each team may be changed after each shot.
- The official scorekeeper shall record all shots taken indicating the players, goalkeepers and goals scored.

D. Point Credited

A team winning a shootout shall be credited with one additional goal.

ANNEX E - TIEBREAKERS

Process to Determine Semifinalists and/or Finalists at State/Affiliate and/or District Championships.

During the preliminary rounds, each team will be awarded three (3) points for a win in regulation, two (2) points for a win in overtime or shootout, one (1) point for a loss in overtime or shootout and zero (0) points for a loss in regulation.

High School Divisions – Tie-Breaking Rules to Determine Standings Position

If two or more teams have an equal number of points, their position in the standings shall be determined by the following tie-breaking rules listed below. If at any point during the application of the tie-breaking rules, any or all of the teams can be seeded higher or lower than the other teams, the seeded teams will be placed in their position in the standings and the tie-breaking process will begin at Step 1 for any teams that remain tied. NOTE: If all tied teams have not played each other, the tie-breaking process will begin at Step 2.

The tie-breaker rules are as follows:

Step 1. The results of only the head-to-head games played between the tied teams in the following order:

- a. Most points earned.
- b. Most total wins (whether in regulation, overtime and shootout).
- c. Most regulation wins.
- d. **Differential** Subtracting goals against from goals for in these games, the positions being determined in order of the greatest surplus. A maximum goal differential of plus or minus eight (8) per game will be used in tiebreaking rules.
- e. **Quotient** Dividing the goals for by the goals against in these games, the positions being determined in order of the greatest quotient. If a game has a goal differential of more than eight (8) goals, the goals for will be decreased until there is a maximum of eight (8) more than goals against in a given game prior to dividing (i.e. 10-1 game would use 9-1 for purposes of quotient). A quotient involving dividing by zero (0) has higher standing than a quotient from dividing by any number other than zero (0). Where two or more teams have no goals against and the quotient tie-breaker is required, the teams shall be ranked high to low in descending order of "goals for."
- f. **Most periods won** In the games played by each tied team, points will be awarded for each regulation period won (2 points) and for each regulation period tied (1 point). Positions shall be in the order of highest point total.

Step 2. If after applying the formulas of 1 a, b, c, d, e or f the tie still exists, the results of all the games played by the teams tied in the following order.

- a. Most total wins (whether in regulation, overtime and shootout).
- b. Most regulations wins.
- c. **Differential** Subtracting goals against from goals for in these games, the positions being determined in order of the greatest surplus. A maximum goal differential of plus or minus eight (8) per game will be used in tiebreaking rules.
- d. Quotient Dividing the goals for by the goals against in these games, the positions being determined in order of the greatest quotient. If a game has a goal differential of more than eight (8) goals, the goals for will be decreased until there is a maximum of eight (8) more than goals against in a given game prior to dividing (i.e. 10-1 game would use 9-1 for purposes of quotient). A quotient involving dividing by zero (0) has higher standing than a quotient from dividing by any number other than zero. Where two or more teams have no goals against and the quotient tie-breaker is required, the teams shall be ranked high to low in descending order of "goals for."
- e. **Most periods won** In the games played by each tied team, points will be awarded for each regulation period won (2 points) and for each regulation period tied (1 point). Positions shall be in the order of highest point total. f. Lowest number of penalty minutes Calculate the number of penalty minutes accrued during all preliminary round games. The teams shall be ranked low to high in ascending order of "penalty minutes for."

g. **Quickest first goal** — The team that scored the quickest goal in their preliminary round games shall be ranked highest.

3. If the above procedure does not break the tie, the teams shall use a shootout procedure as previously described.

NOTE: A team may go into the tie-breaking process having defeated another of the tied teams and still not advance.

NOTE: If a team forfeits any of its games, and becomes involved in any tie-breaking formula, the team that forfeited will not advance and all games played against the forfeiting team shall be recorded as 1-0 victories for all opposing teams.

ANNEX F – NHL RULE 84.3

84.3 Overtime – Regular-season – Penalties – When regulation time ends and the teams are 5 on 3, teams will start overtime 5 on 3.

Once player strength reaches 5 on 4 or 5 on 5, at the next stoppage of play, player strength is adjusted to 4 on 3 or 3 on 3, as appropriate.

When regulation ends and teams are 4 on 4 teams will start overtime 3 on 3.

If at the end of regulation time teams are 3 on 3, overtime starts 3 on 3.

Once player strength reaches 4 on 4, 5 on 4 or 5 on 5, at the next stoppage player strength is adjusted to 3 on 3 or 4 on 3 as appropriate.

At no time will a team have less than three players on the ice. This may require a fourth and/or fifth skater to be added in the event penalties are assessed.

<u>Refer to Reference Tables – Table 17 – Penalties In Effect Prior to the Start of Overtime – Regular Season.</u>

If a team is penalized in overtime, teams play 4 on 3. If both teams are penalized with minor penalties at the same stoppage of play (with no other penalties in effect), teams will continue to play 3 on 3.

In overtime, if a team is penalized such that a two-man advantage is called for, then the offending team will remain at three (3) skaters while the non-offending team will be permitted five (5) skaters.

At the first stoppage of play after the two-man advantage is no longer in effect, the numerical strength of the teams will revert back to 4 on 3 or 3 on 3, as appropriate.

<u>Refer to Reference Tables – Table 18 – Penalties Assessed in Overtime – Regular Season.</u>

Once team A has received their second minor penalty, each team must add one player to their on-ice strength. Should the penalty to A23 expire bringing the on-ice strength back to four (4) on four (4) and there is a subsequent stoppage of play, the on-ice strength must be adjusted down to three (3) on three (3) at this point. However, if there is a stoppage of play once the penalty to B17 has expired (and before A7's expires), the on-ice strength would be adjusted to four (4) on three (3). If there is no stoppage in play until both teams have returned to five skaters each, at the next stoppage of play the on-ice strength would be adjusted back down to three (3) on three (3).

ANNEX G – DUAL ROSTER POLICY

NCHSHL DUAL ROSTER POLICY

The League has recently received requests for dual rostering Bantam/ Freshman players on a JV team of our existing NCHSHL member teams. In addition, the League has been alerted to an affiliation between a NCHSHL member team and a CSHL youth team. The current rules require a player to play on one USA hockey roster only and a dual roster must be requested from the League, reviewed and a decision rendered before playing on a NCHSHL team during the regular season.

The League committee has reviewed the policy and reached a solution to promote JV team play and the inclusion of Bantam/Freshman players while still allowing the myhockeyrankings process to reflect the Varsity and JV teams as separate rankings.

The Bantam/Freshman player will remain a member of the youth (Bantam) team as that player's primary team and is free to join any NCHSHL member program after graduating from the Bantam level to the High School level. This player would be exempt from Article IV, D-1, C&D.

Bantam/Freshman players would be allowed to be part of a NCHSHL Varsity roster and be a member of a youth/Bantam team during the regular season. This would include playing in any NCHSHL league games.

In general, the League will approve a separate JV roster that includes a list of approved players on a Varsity roster of the same program and will allow Bantam/Freshman players to be added to this JV roster if the player is able to play at the JV level and is willing to play at this level. A list of approved players on the Varsity roster would be allowed to play in both the JV level games as well as the Varsity League games.

The Varsity team shall determine the top 10 players including goaltenders. This list of the top 10 players would NOT be eligible to play on the JV team. Teams shall submit a list of players not in the top 10 of the Varsity team that would be allowed to play in JV games, subject to the approval of the NCHSHL. This is intended to allow 3rd and 4th line players to be able to develop their skills and increasing playing time at the JV level within the same program. The NCHSHL member program must notify the League prior to playing any JV games with Varsity players, including Bantam/Freshman players.

Addendum 10-14-2018 A player that is eligible to participate on both the Varsity and JV teams can only play in the NCHSHL playoffs for one team – either the American or the National team. This decision must be made by the NCHSHL League member by February 1st of each season
