GENERAL RULES

- The Holiday Ice Spectacular is open to all members of the Ice Den Chandler's figure skating community.
- Skaters are limited to one solo performance. (Sibling duets and synchro can also perform a solo).
- **Performance fee: \$45**
Entry fee due for each solo registration must be completed online prior to registration deadline.
*Sibling duets must register one performer at duet registration price and one performer at duet \$0.
(Family name must be listed in the comments as check out)
- Music must be holiday themed.

All registrations and music must be submitted by: SATURDAY, DECEMBER 5, 2020

ENTRIES

- All registrations must be completed online at www.icedenchandler.com/its-news-and-events. The Administration Desk will not be accepting registrations or waivers.
- All entries will be scheduled on a first-come, first-serve basis, skaters are encouraged to register early to avoid disappointment.

REFUNDS

Refund requests will be considered only in the event of an injury. All requests must be submitted in writing within seven days of the injury and must be accompanied by a physician's statement indicating the nature of the injury and the length of recovery. As entries are processed on a first-come, first-served basis, in the event a skater cannot be scheduled due to timing constraints, a full refund will be issued.

SKATING TIME LIMITS

- Snowplow Sam through Pre-Free Skate - 1:00 max (solos, duets)
- Free Skate 1 through Pre-Juvenile - 1:15 max (solos, duets)
- Juvenile through Senior - 1:40 max (solos, duets)
- Adult - 1:30 max (solos, duets)

ADMISSION IS FREE: MAX OF 2 SPECTATORS PER SKATER, WRISTBANDS WILL BE PROVIDED
