USIBA LBC #61-CRITERIA TO SANCTION A CLUB SHOW WITH USIBA

Clubs requesting a sanction for an event through USIBA must meet the following criteria.

- 1. Any club requesting a sanction must be a registered club of USIBA.
- 2. There must be a reasonable expectation that at least 50% of the athlete participants are registered USIBA members.
 - It is understood that due to unforeseen circumstances (athletes not showing/making weight/etc.) that this may not always be possible however, an event will not be sanctioned by USIBA if there is advance knowledge that at least 50% of the participants will not be registered USIBA members.
 - The only exception to this rule is if the resident LBC has been notified that the event will contain more resident LBC members than USIBA members and the resident LBC has agreed to sanction with USIBA. Documentation of this is required.
- USIBA cannot be utilized as an alternative to applying for sanctions through your resident LBC. USIBA
 sanctioned events are to provide boxing opportunities for collegiate athletes within their local
 communities.
- 4. Sanctions are approved for USIBA clubs with the expectation that these events are to gain the necessary experience in preparation for the USIBA National Tournament and that registered USIBA clubs will participate in the USIBA National Tournament.
- 5. Sanctions must be submitted 21 calendar days prior to the event to allow the necessary time for the coordination of officials.
- 6. The USIBA Chief of Officials must be notified prior to a request for sanction and details of the event must be clearly relayed.
- 7. All sanction requests will be approved by the USIBA President.

Upon approval of a Sanction through USIBA the following policy must be adhered to:

- The USIBA Chief of Officials will contact the event holder to discuss the event and provide assistance if needed.
 - At this time a consensus will be reached as to the entering of competition results into MatchTracker.
 - If the event holder will be responsible for entering the competition results into MatchTracker this must be completed within 5 days following the event.
 - ➤ If USIBA will enter the competition results into MatchTracker the results must be provided to the USIBA Chief of Officials, via email, within 2 days following the event.
 - All bouts will be recorded on the official Competition Results/MatchTracker form (enclosed) to include bout#, division, weight class, athlete name (red/blue), USA Boxing member ID number, winner, and type of win.
- Issuance of passbooks to any other LBC members other than USIBA is not permitted. Approval from the USIBA Registration Chair or Satellite Registration Chair is required prior to the issuance of passbooks to USIBA members at any event.
