# AHAI BOARD OF DIRECTORS MEETING April 2, 2018

President Dunne called the meeting to order at 6:37 PM. The Minutes from the February and March 2018 meetings were distributed and discussed. Bill Crowley made a motion to approve the February 2018 minutes with a second by Gregg Chudacoff. These minutes were approved. Chuck Smith made a motion to approve the March 2018 minutes with a second by Jim Clare. These minutes were approved.

## **Treasurers Report-Bill Crowley**

The need to separate some schools from certain combined programs, 3. Players in these combined programs can stay until graduation, 4. Homogenize rules.

Anita Lichtenberg noted that the Girls HS Showcase team has been selected and is ready to compete in April. Mike Mullally indicated that the same was true for the Boys HS Showcase team. Mike also mentioned that he was able to secure spots on other teams for the three alternate players from Illinois.

#### R&E-Gregg Chudacoff

Gregg indicated that there were several cases that were on the docket for hearings in the coming weeks. It was also noted that there are 6 active SafeSport investigation currently.

## **Tier II-Gregg Chudacoff**

Gregg distributed and discussed a breakdown of the ranking of Tier II teams after the state tournament. He noted that there were 286 teams registered for this years' Tier II boys state tournament. John thanked Gretchen for pulling together at the last minute, a LiveStream broadcast team that did a terrific job.
