There was a slight increase in our rates, 8% total. Very competitive price and West Bend has been a good company to work with.

Balance sheet – The CDs are \$2,518,7296 There is \$1,768,478.03 total cash in the bank. Total assets are \$2,023,280.20

P & L -

Favorable: Soccer (increased player count, but is timing for now) Volleyball (driven by registration and being up in numbers) Lacrosse (timing of registration and league fees, expected in May and June and checks are out) Softball (missing fundraising deposits going in tomorrow)

Unfavorable: Baseball (off on timing of uniform purchase) Basketball (got a budget this month, officials, and refs) Football (timing of equipment), Hockey (the ice bill and goalie equipment came in, ice bill was higher than expected),

Main Board – due to audit and paying for it still Budgets needed: basketball is being trained currently

Overall, we are up about \$104,000 (without gambling)

Kim made a basketball budget to help them out, Dan asked her to share it with the group. Dan paid Kim \$250 to create a budget for their treasurer. She showed the budget she made for them. No one had questions for her.
