



WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK/WAIVER OF LIABILITY/INDEMINFICATION AGREEMENT:

In consideration of being allowed to participate on behalf of the Adrian Dirtbags Baseball and Softball program and related events, activities, and tournaments, the undersigned acknowledges, appreciates, and agrees that:

1. Participation includes possible exposure to an illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. I KNOWINGLY AND FREE ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards to protection against infectious diseases. If, however, I observe any unusual or significant symptoms during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately, and,
4. I, for myself and behalf of my heirs, assigns, personal representative and next-of-kin, HEREBY RELEASE AND HOLD HARMLESS the Adrian Dirtbags Baseball and Softball Association, their officers, officials, employees, partners, coaches, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"). WITH RESPECT TO ANY AND ALL DISABILITY, DEATH, or loss or damage to person or property. WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I further understand the Adrian Dirtbags have offered a complete refund of any monies not already spent. Certain monies have been spent prior to the outbreak of COVID-19 and the corresponding global pandemic. The Adrian Dirtbags have made it clear that no child or family is forced to participate and the Adrian Dirtbags will offer a complete total accounting and offer a full refund of monies not already spent (i.e. tournaments, fees, uniforms and costs associated were purchased and distributed and cannot be refunded).

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights of myself and on behalf of my minor child and sign it freely and voluntarily without any inducement.
