The Annual Meeting was called to order by President Frank Buonomo at approximately 7:05 p.m.

#### **Minutes**

• The minutes from the 2017 annual meeting were reviewed by the attendees. A motion was made to approve the minutes. The motion was seconded and the minutes were then approved by voice vote.

# **Treasurer's Report**

• Dave Speer presented the treasurer's report (attached).

### **Executive Committee Reports**

• There were no Executive Committee reports.

### **Standing Committee Reports**

• There were no Standing Committee reports.

### **Other Committee Reports**

• Brad Sileo presented proposed changes to the Upper St. Clair Hockey Association Bylaws. It was noted that the recommended changes to the Bylaws had been reviewed and

recommended by the Board at a prior meeting. In addition to minor stylistic changes, the three most significant proposed changes to the Bylaws were discussed: (a) Modifying the definition of "Active Member" to eliminate confusion; (b) Modifying the definition of "Executive Committee" to make it consistent with normal Board practice; and (c) Adjusting the term length of six Board positions (President, Treasurer, Secretary, Vice President—Operations and Coaching, Vice President—Registrar and Vice President—Fundraising) from one to two years on a staggered basis. (Specific details on these changes are included in the attached redlines.) A motion was made to approve proposed bylaw changes. The motion was seconded and the bylaw revisions were approved unanimously by the membership by voice vote.

- Frank Buonomo provided an update on the coaching staff. Frank noted that Ray Conway will not return as Varsity Head Coach. Frank stated that a Coaching Committee has begun the process of interviewing candidates and that the intent is to finalize the head coaching position prior to tryouts, which begin on May 14, 2018.
- Cormac McCarthy provided an update on the Junior Panthers. Cormac stated that the program has been successful and that he hopes for continued success. It was noted that due to Cormac's son aging out of the Junior Panthers program, Cormac is stepping down from his role. The Board and Membership applauded Cormac and thanked him for his years of dedicated service to Junior Panthers. Cormac introduced Matthew Breneman, who will take over responsibility for the Junior Panthers Program.
- John McShane provided an update on uniforms and equipment. John explained to the Membership that the Board had approved a change in uniform vendors from KO Sports to Pure Hockey. The change in vendors is intended to provide cost savings to members along with shipment of uniforms directly to members' homes.

- A vote by written ballot was conducted for the contested position of Treasurer. In addition to

  Treasurer.
- Regarding those positions for which only one candidate was presented, Frank Buonomo, Pete

  any interest. After these requests, a motion was made to close the nominations and to declare
