PARTICIPANT VOLUNTARILY ASSUMES FULL RESPONSIBILITY for all risks or loss, property damage, or personal injury, which may be sustained by Participant or loss of damage to property owned by Participant as a result of Participant's involvement in these events and use of facilities.

Participant hereby RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Neenah Boys Hoops Club, the officers, agents and employees hereinafter from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, injury or illness that may be sustained by Participant or to any property belonging to Participant while engaging in physical activity while on or upon the premises or facilities where the events are held, indoor practices and workouts, league and tournament games, and any scrimmages that take place as of this date and all dates through the Neenah Basketball Academy.

It is the Participant's expressed intent that this Release and Waiver of Liability Agreement shall bind the members of Participant's family. Participant hereby further agrees that this Release and Waiver of Liability Agreement shall be constructed in accordance with the laws of the State of Wisconsin.

Participant voluntarily agrees to assume all of the foregoing risks and accept sole responsibility for any injury to him (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that Participant may experience or incur in connection with his attendance or participation in the Neenah Basketball Academy ("Claims").

In signing this release, Participant acknowledges and represents that he/she has read the foregoing WAIVER OF LIABILITY AND THE HOLD HARMLESS AGREEMENT, UNDERSTANDS IT, AND SIGNS IT VOLUNTARILY as Participant's own free act and deed; No oral representations, statements or inducements, apart from the foregoing written agreements have been made; and Participant executes this release for the full, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.
