1. Accept minutes from last months meeting

2. Treasurer's report

3. Policies and Bylaws

There was a meeting a week and a half ago, going over the policies and bylaws. A lot of repetition was removed, the policies and bylaws were streamlined, language was updates in the bylaws. Should have a printed version for everyone to look at in the next few weeks. They will be sent out for review prior to a vote. 4. Player petition

A player attends Timberline and his father was asked to help coach the Borah program. In the past we have done this with other coaches and their sons, so there is a precedent. Currently playing for Borah, which is against league rules, as the petition had not been granted. The way it was handled was incorrect.

*Batholomew motion/Warchol seconded to grant the player petition. Motion passes.*

5. Open

- Batholomew raised the issue of advancing the sport, and the hit or miss of the TVYLL coaching program. Meridian is allowing 8th graders to play on the jv team. Since the deadline for a vote among the league was the 28th, and nothing was sent out, Meridian did accept Mountain View players. On the 12th, the email went out saying that 8th graders were not allowed to play for another school. Players had already registered and money had changed hands. There will be a combined Meridian/Mountain View JV team. They have written in their bylaws that this is for this year only, that these Mountain View players will not be able to play for Mountain View as 9th graders or beyond.
- Additionally, for clarification. The Meridian program was asked to turn in their jv roster on a particular date which was March 18, and again to Bobby to confirm that she had it on 4/8. (30 days before the first game), and yet two hours before a game they were informed that there were no referees. According to Russ, the ILOA was working off an old master schedule. Timberline jv also had a game cancelled last Friday, and according to Russ it was just never assigned. Bobbi said that nothing was sent over

from ILOA, she did not have the proper information to confirm the earlier games. ISHLL is working on a system that will inform and verify the schedule two weeks in advance.

- Emails are going out that stats have to be entered. However, the rosters have not been set up. As of this afternoon, the website was not available. Russ said that some programs are having issues while others are not. Please continue to try to enter your stats. If you have problems, please reach out to Russ ASAP.
- There is an online reporting system on the IHSL website. If you have concerns or issues with refereeing at games, please use this system to report any issues.
- A reminder that if a player is ejected from a game for behavior, Russ needs to be contacted and informed by the referee within 24 hours.
