Travel uniforms:

Discussion: In-house 9-12 tournament teams

Met with Jamie Barthel from the city to discuss make in-house baseball more competitive.

- -Add an in-house tournament team to 9-12 in-house teams. Wayzata and Champlin do this.
- -Create a tournament team. Details to be discussed by sub-committee.
- Each team can play in 2 tournaments; ABA will pay for 1 and the team will pay for the other if they choose to do more.
- these teams cannot go to any tournaments that our travel teams are in.

#### **Motion By Steve Eckes:**

Second by Katie Seidenkranz to initiate tournaments teams for the in-house ages, 9, 10, 11, 12 where ABA will fund the inaugural jersey and 1 tournament. ABA board members will run the tryouts. 11 and 12 U based on numbers with either be 11 and 12 or we may need to consolidate to 11/12. These tournament teams can only go to A level tournaments MYAS and MBL where ABA travel teams are NOT already registered. They can attend non MYAS and non-MBL tournaments at their won discretion. The maximum number of tournaments is 2. Approved without dissent.
