### **2022-2023 JV/ VARSITY COMMITMENT CONTRACT AND PAYMENT AGREEMENT**

This Commitment Contract sets forth the 2022-2023 contract and payment agreement between you and the THOMAS JEFFERSON HOCKEY CLUB (referred to as TJHC)

#### **The season fee for 2022-2023:**

<b>1. JV/Varsity players will not exceed \$2,400.00, which includes two weekly practices.</b>
<b>2. JV/Varsity goalies will not exceed \$1,800.00</b>
<b>3. JV/Varsity back-up goalies will be \$1,600.00</b>
<b>THERE ARE ADDITIONAL FEES AND RESPONSIBILITIES INCLUDING TOURNAMENT FEES, UNIFORM COSTS &amp; MANDATORY FUNDRAISERS</b>

\*\*\*The 2022-2023 season commences in the summer of 2022 and concludes in March 2023. \*\*\*

1. A \$300.00 deposit and this form must be returned to TJHC by **May 27, 2022**, to accept a position on a team(s). If you accept, you will become obligated to pay the entire season fee. The \$300.00 deposit will be applied to the season fee and is not refundable after acceptance. Furthermore, the entire season fee is due and owed upon acceptance of a position. If not registered by **May 27, 2022**, a late fee of \$150 WILL APPLY.

**2. The balance of the season fee is payable on February 28, 2023**, and collected via automatic payment via TJ Hockey Sports Engine site. The following schedule of equal payments will be processed accordingly:

<b>August 15, 2022</b>
<b>September 15, 2022</b>
<b>October 15, 2022</b>
<b>November 15, 2022</b>
<b>December 15, 2022</b>
<b>January 15, 2023</b>
<b>February 15, 2023</b>

*Failure to process an installment payment by the due date accelerates the entire unpaid balance of the season fee and it will be immediately due and payable. Failure to make payments in accordance with this contract will permit the Thomas Jefferson Hockey Club to deny your child the privilege to practice and play.*

**3. IT IS AGREED THAT IF, AT ANY TIME AFTER ACCEPTANCE OF A POSITION, YOUR CHILD WITHDRAWS FROM THE TEAM, DECLINES THE POSITION, LEAVES TO PLAY FOR ANOTHER ORGANIZATION OR TEAM, IS SUSPENDED OR TERMINATED FOR DISCIPLINARY REASONS, OR CANNOT PLAY DUE TO INJURY OR SICKNESS, YOU ARE STILL RESPONSIBLE FOR THE PAYMENT OF THE ENTIRE SEASON FEE AND ANY OTHER UNPAID BALANCES.**

4. All money earned from fundraising will be applied to the player's account. If you decide to leave the organization for any reason, those credits belong to the TJ Hockey Club.

5. All parents are required to volunteer their time in helping with the team (gate, scoresheet, time clock, 50/50, etc.). If you do not work your scheduled slots, an additional \$75.00 will be added to your bill. If you choose to submit a payment instead of helping, please make arrangements with Treasurer Carolyn Smith.

6. In the event of failure to make any required payment under this Contract, or any other payment required in connection with your child's participation in the THOMAS JEFFERSON HOCKEY CLUB, you hereby acknowledge and agree that your child shall not be permitted to participate in practices, and agree that the THOMAS JEFFERSON HOCKEY CLUB may notify any other governing organizations of the PIHL or amateur hockey of any failure to make a required payment which can affect your child's ability to play hockey both in the present and the future.

7. In the event that there is a failure to make any payments required by this Contract, and Agreement you agree that the THOMAS JEFFERSON HOCKEY CLUB may commence an action before any court of competent jurisdiction, within the Commonwealth of Pennsylvania, including a district justice or magistrate to collect any unpaid amounts, including collection costs and attorney fees.
8. This Contract and Agreement contains the complete and exclusive agreement between the parties and cannot be modified by any oral statements, communication, or representations of any persons, including officers or Board Members of the THOMAS JEFFERSON HOCKEY CLUB.
