The COVID-19 pandemic has presented athletics across the world with myriad of challenges concerning this highly contagious illness. Some severe outcomes have been reported in children, and a child with a mild or even asymptomatic case of COVID-19 can spread the infection to others who may be far more vulnerable. While it is not possible to eliminate all risk of furthering the spread of COVID-19, KMB Sports, LLC DBA Border Select Basketball (hereinafter referred to as "Border Select Basketball") will take necessary precautions and comply with guidelines from the federal, state, and local governments, CDC, and applicable Departments of Health, to reduce the risks to students, coaches and support staff. **PLAYER COST/SCHEDULE**

This information is provided to help give you an idea of cost based on the number of events teams participate in. Our “base” cost is \$525 for five events. The playing season will be April, May and early June. Events will include regional club tournaments and Minnesota Youth Athletic Services events (MYAS). Some teams will continue to play into the summer in regional and nationally recognized events. Additional Tournaments will increase cost per player. As an example (6) Tournaments = \$615 etc.

Please note that participation cost could change due to an increase in tournament fees due to no admission costs for spectators. Exact Cost and schedule will be set once our teams and schedule has been selected.

**PRACTICES**

Teams will start practicing at the end of March. Teams will practice 1.5 hours - twice a week. We encourage players to play other sports in the spring – once we set teams and understand everyone’s schedule, we will do our best to schedule practices that work best for team members and our coaches. Practices will be held in Page Arena at UWRF and Hudson High School.
