Sherry states that she spoke with Melissa about her behavior on the ice and is hopeful that this will help resolve the issue. Due to history of complaints, game misconduct in 2017 Ruicci Cup and recent complaint, the board issued a 2 game suspension effective 11/13/18, after which Melissa will be on probation. Any additional complaints and/or aggressive penalties will be investigated after which the board may seek further disciplinary action up to and including suspension from the league.

    representing April. Samantha explained that the late complaint
    was due to her injury and recognizes that it was submitted

outside of the 14 day window. The board also recognizes that while the complaint is late, due to Section XVI B of the handbook in the interest of sportsmanship and safety that the board can take whatever action necessary to eliminate problems in the future. The board decided to issue a verbal warning to April regarding physical play and body awareness. The board will continue to monitor the issue and plans to observe a game that April plays in.
