### 1. Call to order/Welcome (Moe); Attendance (Gerber)

- a. <u>Secretary's Report</u> review/acceptance (**Gerber**)
- **b.** Treasurer's Report (Empey)
  - i. Account Balance as of \$30,387.03
  - ii. \$3.00 banking fee since September meeting

- **c.** Officials Report (**Arendt**)
  - i. Tests and videos are active online for coaches on WIAA website

- ii. First of 2 Zoom Officials Clinics beginning this upcoming Tuesday @ 8-9:30
- **iii.** Currently reviewing headgear/masks for upcoming season
  - 1. Masks are going to be tight fitting
  - 2. Masks can't have loops in the back that fingers can get caught in
  - 3. Gaiters/Buffs cannot be used in wrestling due to strangulation concerns
- **iv.** Reiterated how cognizant coaches/schools are in scheduling duals given how many officials are not going to be officiating this season i.e. every conference can't go on the same night due to lack of officials
- v. Lancaster asked about whether there is any discussion happening regarding safety of wearing masks during wrestling. Arendt responded that the Governor's mask mandate supersedes the WIAA rule. There has been conversation around masks with Medical Advisory but right now, there isn't an option due to the Executive Order.
- **vi. Schimming** asks how these wrestling events are able to go without wearing masks. **Arendt** said that it's up to local law enforcement to police the mandate.
- **Potratz** asked how officials will rule on masks, if they're pulled off or if it comes off. **Arendt** said that it will be officiated similar to required equipment. If a hand gets caught in similar to singlet; if it falls off unintentionally stop the match and fix; if a kid is on his back will the match stop probably not.

### **d.** Awards Report (Potratz)

- i. Virtual Clinic Awards has gone pretty good
- **ii.** Thanked everyone for getting him information and thanked presenters that helped during the Virtual Clinic
- **iii.** All Awards have been received is going through the process of sorting now for disbursement
- **iv.** Taking pictures of the awards that we have for archiving **Bean** mentioned that the pictures may be used for future bids on awards but also for posting on our WWCA website.
- **v.** Will get awards to District Reps for disbursement

### **e.** Public Relations Report (**Stromberg**)

- **ii.** Everyone acknowledges that everything is up in the air at this time.

### **f.** WWF Report (Verbeten)

- i. Discussed the email sent from Dave Black about a December tournament Sectional like event.
  - 1. Not a WIAA sanctioned event
  - 2. Sounds like attending this event must follow the 6-7 day WIAA protocol
    - a. Bean mentioned that in the Presidents' meeting with Wade, he said the 6-7 day window would still apply. Moe reiterated this.
  - 3. Date to respond to WWF is November 11th decision to host is based on responses to this. This is just to get a feel for the amount of kids that may come doesn't lock anyone into anything.
    - a. Requires school approval
    - b. Requires parents to take kids to the event
    - c. Requires USA Card

- d. Tournament during the season so specific paperwork needs to be filled out prior to kids going there. Eligibility issues may arise without proper paperwork.
- 4. The tournament would be a Sectional like event so teams would enter 1 entrant per weight bracket.

  - i. Challenge Series Cancellation for 20-21 season
    - 1. Contacted and polled coordinators via email regarding holding Challenge Series
    - 2. Consensus amongst all coordinators was to suspend for the 2020-2021 season.
    - 3. Many schools wouldn't be available to host; many schools wouldn't be able to participate
  - ii. Fiedler asked for a financial update on the Challenge Qualifier/Tournament
    - 1. Biggest cost to WWCA for running this event is about \$1,000
    - 2. Many costs are picked up by private donors at this time **Bean** asked whether the WWCA would need to pick up costs of the tournament if donors didn't choose to pick up costs in the future. **McGarvie** mentioned that he'd look for new sponsors in the event that would happen.
