### **TOURNAMENT GUIDELINES**

TEAM TOURNAMENT FEES: \$1200 DEPOSIT: \$500, BALANCE DUE: \$700 THE ABOVE COSTS INCLUDE ICE TIME, REFEREES, SCOREKEEPER'S FEES, MEDALS AND BANNERS. BALANCE OF TOURNAMENT FEES (CHECKS PAYABLE TO IDAHO AMATEUR HOCKEY ASSOCIATION) WILL BE DUE AND COLLECTED BY JOHN HEINRICH OR KAILA TANNER PRIOR TO THE TEAM'S FIRST GAME. TEAMS WILL NOT PLAY IF FEES ARE NOT SUBMITTED.

NO ARTIFICIAL NOISE MAKERS, COWBELLS, WHISTLES OR DRUMS WILL BE ALLOWED AT THE STATE TOURNAMENT. YOU ARE RESPONSIBLE FOR SHARING THIS INFORMATION WITH YOUR PLAYERS AND FANS. THIS WILL BE STRICTLY ENFORCED.

#### CONCUSSION MANAGEMENT:

ANY ATHLETE WHO HAS SUSTAINED A CONCUSSION DURING THE TOURNAMENT MUST BE EVALUATED BY A QUALIFIED MEDICAL PROVIDER WHO HAS BEEN TRAINED IN CONCUSSION MANAGEMENT BEFORE RETURNING TO PLAY. HEALTH CARE PROVIDER MUST FILL OUT THE "RETURN TO PLAY" FORM PROVIDED ON THE USA HOCKEY WEBSITE:

WHAT IS THE USA HOCKEY ZERO TOLERANCE POLICY? THIS POLICY REQUIRES ALL PLAYERS, COACHES, OFFICIALS, TEAM OFFICIALS AND ADMINISTRATORS AND PARENTS/SPECTATORS TO MAINTAIN A SPORTSMANLIKE AND EDUCATIONAL ATMOSPHERE BEFORE, DURING AND AFTER ALL USA HOCKEY-SANCTIONED GAMES.

# **GAME/TOURNAMENT FORMAT**

ONLY USA HOCKEY PLAYING RULES AND AGE DIVISIONS MAY BE USED IN TOURNAMENT PLAY. USA HOCKEY OFFICIAL PLAYING RULES AND IAHA TOURNAMENT POLICIES AS OUTLINED HERE WILL APPLY. ALL OFFICIALS ARE USA HOCKEY CERTIFIED AND IN GOOD STANDING. ALL PLAYERS, COACHES, AND MANAGERS MUST BE PROPERLY REGISTERED WITH USA HOCKEY FOR THE CURRENT PLAYING SEASON AND MEET THE HS REQUIREMENT (FULL-TIME STUDENT IN 9TH, 10TH, 11TH, OR 12TH GRADE AND NOT EXCEEDING 4 YEARS OF HS ELIGIBILITY). THE GAME FORMAT WILL BE AS FOLLOWS:

HIGH SCHOOL - 8 TEAMS

•HERE 8 TEAMS WILL PLAY ROUND-ROBIN WITHIN THEIR DIVISION, NATIONAL (4 TEAMS) OR AMERICAN (4 TEAMS).

•FOLLOWING THE ROUND-ROBIN PLAY, THE TEAM IN THE AMERICAN DIVISION WITH THE HIGHEST POINT TOTAL WILL PLAY THE TEAM IN THE NATIONAL DIVISION WITH THE SECOND HIGHEST POINT TOTAL AND THE TEAM IN THE AMERICAN DIVISION WITH THE SECOND HIGHEST POINT TOTAL WILL PLAY THE TEAM IN THE NATIONAL DIVISION WITH THE HIGHEST POINT TOTAL (SEMI-FINAL GAMES).

•THE CHAMPIONSHIP GAME WILL CONSIST OF THE WINNERS OF THE SEMI-FINALS DESCRIBED ABOVE.

#### PLAYING FORMAT:

PLAYING TIMES WILL BE STOP-TIME FOR ALL DIVISIONS. A THREE (3) MINUTE WARM-UP SHALL START AT THE SCHEDULED GAME TIME AND A SIXTY (60) SECOND BREAK WILL BE ALLOWED BETWEEN PERIODS. ONE 30 SECOND TIME OUT WILL BE ALLOWED FOR EACH TEAM DURING EACH GAME. PERIODS SHALL BE 15 MINUTES. WE WILL BE PLAYING WITH A THIRD PERIOD MERCY RULE FOR ALL GAMES DURING ROUND ROBIN PLAY, SO IF A TEAM IS LEADING BY 5 GOALS OR MORE IN THE THIRD PERIOD, THE GAME WILL BE RUN TIME. AT ANY TIME, IF THE DIFFERENTIAL BECOMES LESS THAN 5 GOALS, THE GAME WILL REVERT TO STOP TIME. THE THIRD PERIOD MERCY RULE WILL NOT APPLY DURING SEMI-FINAL OR FINAL GAMES. THERE WILL BE NO OVERTIME PERIODS IN PRELIMINARY/ROUND-ROBIN PLAY. ICE SHALL BE CUT BEFORE EVERY GAME (BUT NOT BEFORE OVERTIME OR A SHOOTOUT).

#### PENALTIES WILL BE SERVED AS FOLLOWS:

#### PENALTY

FOR STOP TIME (MIN.) : MINOR 1:30, MAJOR 4:00, MISCONDUCT 8:00 FOR RUN TIME (MIN.) : MINOR 2:00, MAJOR 5:00, MISCONDUCT 10:00

TEAMS WILL ADVANCE BASED ON THE FOLLOWING SCORING SYSTEM: TWO POINTS FOR A WIN, ONE POINT FOR A TIE, ZERO POINTS FOR A LOSS

#### THE TOURNAMENT DIRECTOR, AT HIS DISCRETION, HAS THE AUTHORITY TO: 1. SHORTEN THE PERIOD 2. AUTHORIZE RUNNING TIME DEPENDING ON THE SITUATION 3. SHORTEN THE WARMUP PERIODS

TIE-BREAK PROCEDURE WILL FOLLOW USA HOCKEY NATIONAL TOURNAMENT GUIDEBOOK: NOTE: IF ALL TIED TEAMS HAVE NOT PLAYED EACH OTHER, THE TIE-BREAKING PROCESS BEGINS AT STEP 2.

STEP 2: THE RESULTS OF ALL THE GAMES PLAYED BY THE TEAMS TIED IN THE FOLLOWING ORDER. A. MOST TOTAL WINS (WHETHER IN REGULATION, OVERTIME AND SHOOTOUT).

**B. MOST REGULATIONS WINS.** 

C. DIFFERENTIAL – SUBTRACTING GOALS AGAINST FROM GOALS FOR IN THESE GAMES, THE POSITIONS BEING

DETERMINED IN ORDER OF THE GREATEST SURPLUS. A MAXIMUM GOAL DIFFERENTIAL OF PLUS OR MINUS

EIGHT (8) PER GAME WILL BE USED IN TIE-BREAKING RULES.

D. QUOTIENT – DIVIDING THE GOALS FOR BY THE GOALS AGAINST IN THESE GAMES, THE POSITIONS BEING

DETERMINED IN ORDER OF THE GREATEST QUOTIENT. IF A GAME HAS A GOAL DIFFERENTIAL OF MORE THAN EIGHT (8) GOALS, THE GOALS FOR WILL BE DECREASED UNTIL THERE IS A MAXIMUM OF EIGHT (8) MORE THAN GOALS AGAINST IN A GIVEN GAME PRIOR TO DIVIDING (I.E. 10-1 GAME WOULD USE 9-1 FOR PURPOSES OF QUOTIENT). A QUOTIENT INVOLVING DIVIDING BY ZERO (0) HAS HIGHER STANDING THAN A QUOTIENT FROM DIVIDING BY ANY NUMBER OTHER THAN ZERO. WHERE TWO OR MORE TEAMS HAVE NO GOALS AGAINST AND THE QUOTIENT TIE-BREAKER IS REQUIRED, THE TEAMS SHALL BE RANKED HIGH TO LOW IN DESCENDING ORDER OF "GOALS FOR."

E. MOST PERIODS WON – IN THE GAMES PLAYED BY EACH TIED TEAM, POINTS WILL BE AWARDED FOR EACH REGULATION PERIOD WON (2 POINTS) AND FOR EACH REGULATION PERIOD TIED (1 POINT). POSITIONS SHALL BE IN THE ORDER OF HIGHEST POINT TOTAL.

F. LOWEST NUMBER OF PENALTY MINUTES – CALCULATE THE NUMBER OF PENALTY MINUTES ACCRUED DURING ALL PRELIMINARY ROUND GAMES. THE TEAMS SHALL BE RANKED LOW TO HIGH IN ASCENDING ORDER OF "PENALTY MINUTES FOR."

G. QUICKEST FIRST GOAL – THE TEAM THAT SCORED THE QUICKEST GOAL IN THEIR PRELIMINARY ROUND GAMES SHALL BE RANKED HIGHEST.

#### SEMI-FINAL AND CHAMPIONSHIP GAMES:

IN THE EVENT OF A TIE SCORE FOLLOWING THE END OF REGULATION, FOLLOWING A SIXTY (60) SECOND BREAK, THE GAMES WILL BE DECIDED AS FOLLOWS:

A. A FIVE (5) MINUTE 4 VS 4 SUDDEN DEATH OVERTIME PERIOD WILL BE USED; TEAMS DO NOT CHANGE ENDS AT ANY TIME.

B. IF THE SCORE IS STILL TIED AFTER THE FIRST OVERTIME PERIOD, A FIVE-PLAYER SHOOTOUT WILL BE USED TO DETERMINE THE WINNER. THE DECISION TO PROCEED WITH A SHOOTOUT IS MADE BY THE TOURNAMENT DIRECTOR. EACH TEAM PICKS FIVE PLAYERS AND THE TEAM THAT GETS THE MOST GOALS IN THE FIVE-PLAYER SHOOTOUT IS THE WINNER. IF AFTER THE FIRST FIVE PLAYERS OF EACH TEAM HAVE SHOT AND THE SCORE REMAINS TIED, THE FORMAT GOES TO A ONE-TO-ONE FORMAT UNTIL THERE IS A WINNER. A TEAM SHALL NOT USE A PLAYER A SECOND TIME UNTIL ALL PLAYERS ON THE TEAM HAVE SHOT. THE TEAM WITH THE LARGER NUMBER OF PLAYERS MAY START TO RECYCLE THEIR PLAYERS WHEN THE TEAM WITH THE LESSER NUMBER OF PLAYERS BEGIN A NEW ROTATION. PLAYERS IN THE PENALTY BOX AT COMPLETION OF PLAY AT THE END OF THE GAME ARE NOT ELIGIBLE TO PARTICIPATE IN THE SHOOTOUT.

#### **APPEALS AND PROTESTS:**

THE TOURNAMENT DIRECTOR SHALL APPOINT A DISCIPLINE COMMITTEE, WHICH SHALL BE **RESPONSIBLE FOR DECIDING ANY ACTION. SUSPENSION OR OTHERWISE. TO BE TAKEN** AGAINST A PLAYER OR TEAM OFFICIAL RECEIVING A MATCH OR GAME MISCONDUCT PENALTY, GAME MISCONDUCT PENALTIES AND SUBSEQUENT GAME SUSPENSIONS. ACCORDING TO USA HOCKEY RULES, ARE NOT SUBJECT TO APPEAL. IN ACCORDANCE WITH USA HOCKEY RULES. THE TOURNAMENT DIRECTOR SHALL REPORT EACH MATCH PENALTY DIRECTLY AND PROMPTLY TO THE STATE PRESIDENT AND ROCKY MOUNTAIN DISTRICT REFEREE-IN-CHIEF. HEARINGS REGARDING MATCH PENALTIES AND ACTIONS IN RESPONSE TO SAME CAN BE INITIATED ONLY BY THE AUTHORITY OF THE IAHA PRESIDENT. THE TOURNAMENT DIRECTOR SHALL APPOINT A PROTEST COMMITTEE, WHICH SHALL REVIEW AND ACT ON, IN A TIMELY MANNER, EACH PROPERLY DOCUMENTED AND SUBMITTED PROTEST. EACH PROTEST MUST BE IN WRITING AND SUBMITTED TO THE TOURNAMENT DIRECTOR NOT LATER THAN ONE (1) HOUR AFTER THE END OF THE GAME OR INCIDENT TRIGGERING THE PROTEST. THE PARTY FILING THE WRITTEN PROTEST MUST ACCOMPANY THE PROTEST WITH A NON-REFUNDABLE FEE OF \$100.00. THE TOURNAMENT DIRECTOR WILL NOT ACCEPT A PROTEST CONTESTING A REFEREE'S JUDGMENT CALL OR THE PLAYING RULES OF THE ASSOCIATION CHAMPIONSHIPS.
