- **Free Throw-A-Thon Recap** - Ten teams participated. We made just over \$2,600. Big drop from last year's participation. Ideas - Possibly get teams together for a free throw event or night to make it more of a focussed event. Put the fundraiser online. Share expectations with coaches that they handout and fulfill counting throw ins at practice.
- **3rd Grade Skills Recap** - Boy's skills night 2/15 was a success. Girl's skills night will be 2/22.
- **1st and 2nd Grade Boys Last Day** - Friday, 2/23. Mini-tournament with concessions and a bracket. Tyrone and Krisi will contact John about referees.
- **Reviews** - Looked over survey questions for end of season surveys. Adding a coach survey.
- **Spring Little Dribblers** - John Crawford will be taking care of spring Little Dribblers sessions. Dates are TBD.
- **Middle School Collaboration** - 8th grade boys had a good experience with added practice time/games and coaching availability. More conversation needed to see if this could be a continued successful collaboration.

■ Off Season Activities - Incentives for summer practices like “Dribble Up” “SIQ” ball competition. Tyrone will look into cost options.

■ Spring Ball - We will add on the “off-season” tab opportunities for extended seasons, camps, etc. to the website.
