RULES

Coaches check in at concession table when arrive - **turn in JVA Coaches Sign in Form (attached to email)**

Gym will open at 7:30am-**OUTSIDE DOORS WILL NOT BE OPEN BEFORE THAT**

Bring your own volleyballs and please make sure they are labeled

Team camp areas should be set up in the back of the commons area. Please do not leave player bags on the tables

Warm up for each teams' first match: 10 minutes (2-4-4); 2 minutes shared – 4 minute serving team – 4 minute receiving team

Warm Up for ALL following Matches: 5 minutes (1-2-2) 1 min shared, 2 mins serving team, 2 mins receiving team

TEAMS WILL REMAIN ON THE SAME SIDE OF THE COURT FOR THE ENTIRE MATCH. No switching sides between sets.

Refing team must provide: R1, R2, 2 line judges, libero tracker, score book keeper and score chart person. **Coach must be R1 OR R2**

There will only be a replay called if ball comes onto the court that interferes with play

Athletes are allowed to step into the other court if it does NOT INTERFERE with play. This is a judgement call by the ref

All match start times are approximate and warm ups will begin immediately after conclusion of previous match

All teams are guaranteed minimum of 4 matches

Concessions will be available - NO COOLERS OR OUTSIDE FOOD ALLOWED

Tournament t-shirts will be for sale (short sleeve \$15, long sleeve \$20)

Admission: \$8 adults, \$5 students and senior citizens, 12 years and younger FREE

All Pool Play Matches: Best of 3 with 3rd to 15 pts if necessary. Win by 2, cap of 27 and 17

Pool seedings will based on 1. Most matches won 2. Head to Head 3. +/- Points 4. Coin Flip

Top two seeds (8 total) of each pool will go on to Gold Bracket

Bottom two seeds (8 total) of each pool will go on to Silver Bracket

Bracket play matches: Best of 3 with 3rd to 15 pts. No cap

Bracket play will start at approximately 2:00pm or earlier if all teams are ready to start

Awards will be given to Champions in Gold and Silver Bracket

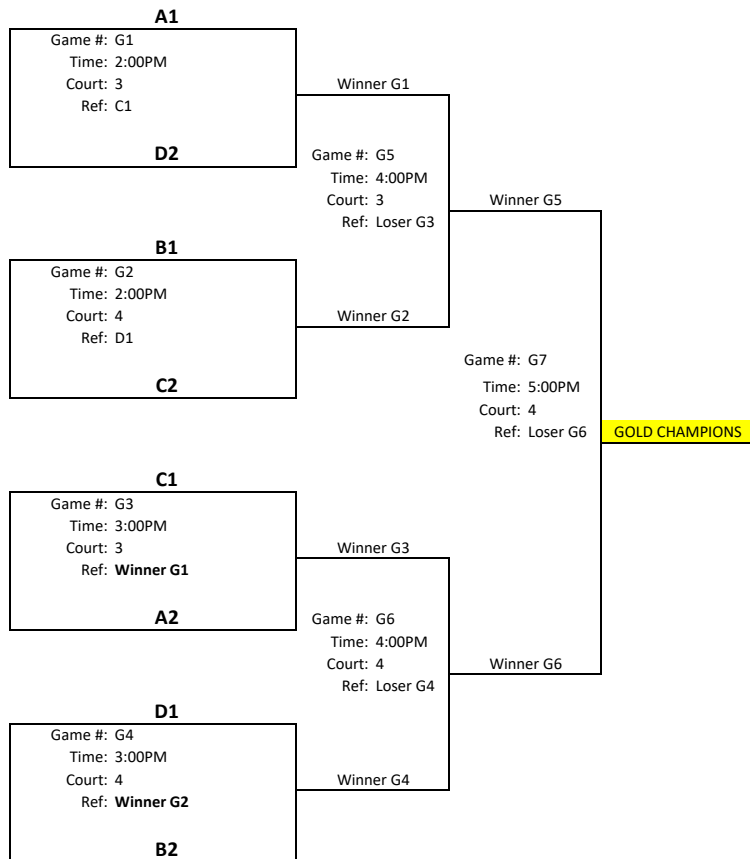
