### CALL BOARD MEETING MINUTES – July 21,2020

LOCATION: Zoom Meeting

Meeting called to order on 06.02.2020 at 7:11PM by Mark Morton.

#### **1. Approval of Minutes from June Meeting**

- a. Motion by Jacki

- c. All agreed

#### **2. Update – Continuation of Spring Season**

- a. City / County Update from Mark Morton –
  - i. Letter from county – no youth sports. Does not qualify as a day camp under guidelines.
  - ii. If we cancel our season, the city may allocate our fields to someone else
  - iii. Corona National and Jurupa cancelled. Norco may cancel soon. Eastvale waiting. Pony will cancel if they cannot get the fields by August 17<sup>th</sup>.
  - iv. Options - Open season as late as Sept 12<sup>th</sup> (only our league), Cancel now and refund money or Clinics in the Fall
- b. Financial Update from Mark Morton
  - i. Refund policy (upon request) - \$30 to Rookie, \$50 to everyone else
  - ii. Choice of issuing refund, apply to 2021 Spring season or donate to league
  - iii. September 30<sup>th</sup> is the end of the fiscal year and board turnover
- c. Annual Meeting
  - i. Usually conducted at closing ceremonies. Zoom this year?
  - ii. Make a recommendation to revamp constitution. Has not been updated since merge. Mark is researching other league websites for their constitutions and bylaws.
- d. Survey Results
  - i. Almost 300 responses out of 330 kids
  - ii. 75% said that they would return
  - iii. 5-10% unsure
  - iv. 40 families requested refunds
- e. Board communication to league
  - i. If fields are not released by September 1<sup>st</sup>, season cancelled
  - ii. Request refund by September 15<sup>th</sup> or donate to league
  - iii. If county removes restrictions, offer fall activities at a low cost
  - iv. Send out communication by August 1<sup>st</sup>
  - v. Motion to approve by Sean. Al seconds the motion. All agreed except -Jacki opposed.
- f. Board member changes
  - i. Danny Magley Resignation
  - ii. Ashleigh Swavely Resignation
  - iii. Sara Beresford Board Vacancy Appointee
