I understand that these injuries or outcomes may arise from my own or others' negligence, conditions related to travel, or the condition of the activity location(s). Nonetheless, I assume all related risks, both known or unknown to me, of my participation in TBC Racing, including travel to, from and during participation in TBC Racing.

I agree to indemnify and hold harmless TBC Racing against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If TBC Racing incurs any of these types of expenses, I agree to reimburse TBC Racing.

I acknowledge that TBC Racing and their directors, officers, volunteers, representatives and agents are not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of TBC Racing.

I acknowledge that TBC Racing may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and/or property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, exposure to viral illnesses, weather, lack of hydration, condition of participants, equipment, vehicular traffic and actions of others, including but not limited to, participants, volunteers, spectators, coaches, event officials and event monitors, and/or producers of the event.

I acknowledge that I have carefully read this "waiver and release" and fully understand that it is a release of liability. I expressly agree to release and discharge TBC Racing and all of its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, from any and all claims or causes of action and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against TBC Racing for personal injury or property damage.

To the extent that statute or case law does not prohibit releases for negligence, this release is also for negligence on the part of TBC Racing, its agents, and employees.

I acknowledge specifically that I am choosing to operate a single, double, pair, quad and 4+ hull without a coach present, and that I agree to indemnify and hold harmless TBC Racing against any and all claims,

suits or actions of any kind whatsoever for liability, damages, compensation should I suffer any injury or harm while operating a TBC Racing boat without a coach present.

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

This Agreement was entered into at arm's-length, without duress or coercion, and is to be interpreted as an agreement between two parties of equal bargaining strength. Both the Participant, and TBC Racing agree that this Agreement is clear and unambiguous as
to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this Agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.
In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.
Additionally, as of March 2020, the participant acknowledges the potential presence of COVID-19 as an emerging threat in the United States of America and hold harmless TBC Racing against any and all claims, suits or actions of any kind whatsoever related to the illness.

I certify that I have read this agreement, that I fully understand its content and that this release cannot be modified orally. I am aware that this is a release of liability and a contract and that I am signing it of my own free will.
