NorCal NAWGJ spent approximately \$34k in the fiscal year. Due to the National pandemic, there was no 2019 Fall Judges Cup (the biggest income & expense generator). Variations from the budget set for the 2019-2020 fiscal year were reviewed. Operating Expense deviation largely explained by the one time fee towards revamping the website.
