#### **QUALIFIED TO APPLY:**

The following is the Standardized Team Placement Rule for the 2024 Tier II Illinois State Hockey Championships.

 $\frac{3 \text{ Teams}}{2^{\text{nd}} \text{ Team will play in the "AA" Division}} = \frac{1^{\text{st}} \text{ Team will play in the "A" Division}}{2^{\text{nd}} \text{ Team will play in the "A" Division}}$ 

3<sup>rd</sup> Team will play in the "B" Division

 $\frac{4 \text{ Teams}}{} = 1^{\underline{st}} \text{ Team will play in the "AA" Division}$ 

2<sup>nd</sup> & 3<sup>rd</sup> Teams will play in the "A" Division

4<sup>th</sup> Team will play in the "B" Division

 $\underline{5}$  or more  $\underline{\text{Teams}}$  =  $1^{\underline{st}}$  Team will play in the "AA" Division

2<sup>nd</sup> & 3<sup>rd</sup> Teams will play in the "A" Division

4<sup>th</sup> & 5<sup>th</sup> and additional Teams will play in the "B" Division

#### "B" Exemption

You may apply for an exemption to play in the "B" Division if your organization has formed only two (2) teams at a level (Squirt, Pee Wee, Bantam) and your team is the 2<sup>nd</sup> team.

#### "AA" Requesting to Play "A"

You are qualified to apply for an exemption to play in the "A" Division if: You are the only team formed at a level by your organization (Squirt, Pee Wee, Bantam and Midget).
